### GE T&D India Limited announces Second Quarter 2017-18 results

New Delhi, India — November 02, 2017 — GE T&D India Limited – a GE Group Company, reported on 02 November 2017 its financial results for the second quarter ended 30 September 2017

#### For the second quarter and six months ended September 17

- Total sales revenue was INR 8.7 Billion, down -1% compared to Quarter Ended (QE) September 16.
   Half year (1 April 2017 30 Sep 2017) revenue was INR 21.3 Billion, +20% compared to half year ended September 16.
- Operating profit for the quarter ended September 17 was at INR 921 Million, against INR 554 Million in QE September 16 and the Net Profit After Tax increased to INR 475 Million, against net profit of INR 205 Million in QE September 16
- New order bookings for half year (1 April 2017 30 Sep 2017) were INR 23.1 Billion, +13% compared to half year ended September 16.

The Company won major orders during the second quarter of financial year 2017-18 from central, state utilities and private developers.
