## About Content Validation

The GE Digital APM product includes baseline content that is owned and controlled by GE Digital APM. Customers can use the GE Digital APM content as a starting point for developing their own content, but the baseline GE Digital APM content should not be modified. Protecting the integrity of the baseline GE Digital APM content is essential for supporting the GE Digital APM database upgrade process and for ensuring that the GE Digital APM product will continue to function properly.

The GE Digital APM product enforces restrictions on modifying baseline content. For example, if you attempt to modify a baseline Rules Library project in the GE Digital APM Rules Editor, you will not be able to do so. As long as these restrictions are in place, the baseline GE Digital APM content will be protected. Through alternate and unsupported workflows, however, it may be possible to modify the baseline GE Digital APM content. If this occurs, you should restore the baseline content immediately.

To help you ensure that your database does not contain any invalid baseline content and to help you detect problems as soon as they occur, GE Digital APM provides the Content Validation tool. Using this tool, you can scan your database for invalid baseline content. Any invalid content that is detected can be exported, after which, GE Digital APM can assist you in restoring the content to a valid baseline state.

The following content is protected by the GE Digital APM Content Validation mechanism:

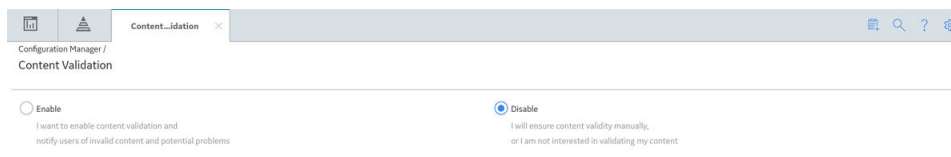
- Catalog folders and items
- GE Digital APM Rules Library projects and code items
- Families
- Fields
- Dependencies used for license activation

When Content Validation is enabled, modifications to and deletions from baseline content will be detected. We recommend that you enable Content Validation to ensure the integrity of your database.

# Enable Content Validation

## About This Task

When content validation is enabled, each time a user navigates to Configuration Manager, a check will be performed to ensure that the baseline GE Digital APM content is valid. If the content is not valid, it will display a warning message. The user will have the option of exporting the invalid content or ignoring the warning.

## Procedure

1. Access the **Content Validation** page.

2. Select **Enable**.

The GE Digital APM system scans your database for invalid baseline content and displays the results on the **Content Summary** section in a grid format. Both modifications to and deletions from baseline content are considered invalid and will be included in the list. It displays the following:

- **Content ID:** The ID of the baseline content.
- **View Name:** The property that will be used by GE Digital APM for recovering the content.
- **Type:** The type of change occurred on the content. For example, if the baseline content is deleted, it displays the Type as Deletion. If the baseline content is modified, it displays the Type as Modification.

**Note:** You can disable the content validation on a database on which the content validation is enabled by selecting **Disable**. The content validation for the baseline content will be disabled and you will no longer receive the warning message in case of a change in the baseline content.

3. If you want to export the list of invalid contents to a .XML file, select **Export**. The .XML file appears.

# About Accessing GE Digital APM When Content Validation is Enabled

## About This Task

When you navigate to Configuration Manager in which Content Validation has been enabled, the GE Digital APM system will scan the database for invalid content. If invalid content is detected, the following warning message will be displayed.

When this warning message is displayed, you have two options for how to proceed:

- You can select **Yes** to check the invalid content. This option is recommended. When you select this option, the **Content Validation** page appears, displaying a list of invalid content in the **Content Summary** section.
- You can select the **No** to bypass the warning and continue using the application anyway. Using a system that contains invalid content is not recommended.
