Overview of the Root Cause Analysis (RCA) Module

The APM Root Cause Analysis (RCA) module lets you conduct a root cause analysis, which allows you to analyze causes of failures. A Root Cause Analysis also allows you to track the performance of the equipment by following implementation of recommendations. When you create a Root Cause Analysis, you are using APM tools to facilitate a standard process that is based on the [PROACT® for Meridium methodology](#).

More Details

A root cause analysis is the process of analyzing failures down to their root causes, which can include but is not limited to physical causes, human causes, and latent causes of the failure.

In the APM system, [elements of a Root Cause analysis](#) store all the information necessary for the team to identify a root cause for failure of an asset.

When the Root Cause Analysis is complete, it can be published and made available to users who are not members of the analysis team, allowing them to view the results using APM tools.

When a failure occurs in your facility, there could be any number of causes that led to the failure. If you investigate the causes, you might find that each failure is caused by another higher-level cause. If this root cause remains unidentified, the failures will likely persist.

For instance, consider an example of a car that has had trouble starting every month for the past three months. In this case, you might determine that:

- In the first month, the cold weather caused the failure.
- In the second month, the battery was low.
- In the third month, the warning to check engine was displayed in the dashboard.

If you were to conduct a root cause analysis on the car, you may find that while each month's failure had its own apparent cause, the root cause of each failure was that a voltage regulator was malfunctioning.

To help you identify the root causes of failures in your facility, you can assemble an RCA Team that will:

- Collect data relevant to the failure.
- Analyze the data.
- Develop hypotheses about the root cause.
- Develop recommendations for preventing the failure from occurring or lessen the impact of the failure in the future.
- Implement recommended solutions.
- Track implemented solutions and re-evaluate them, as needed.

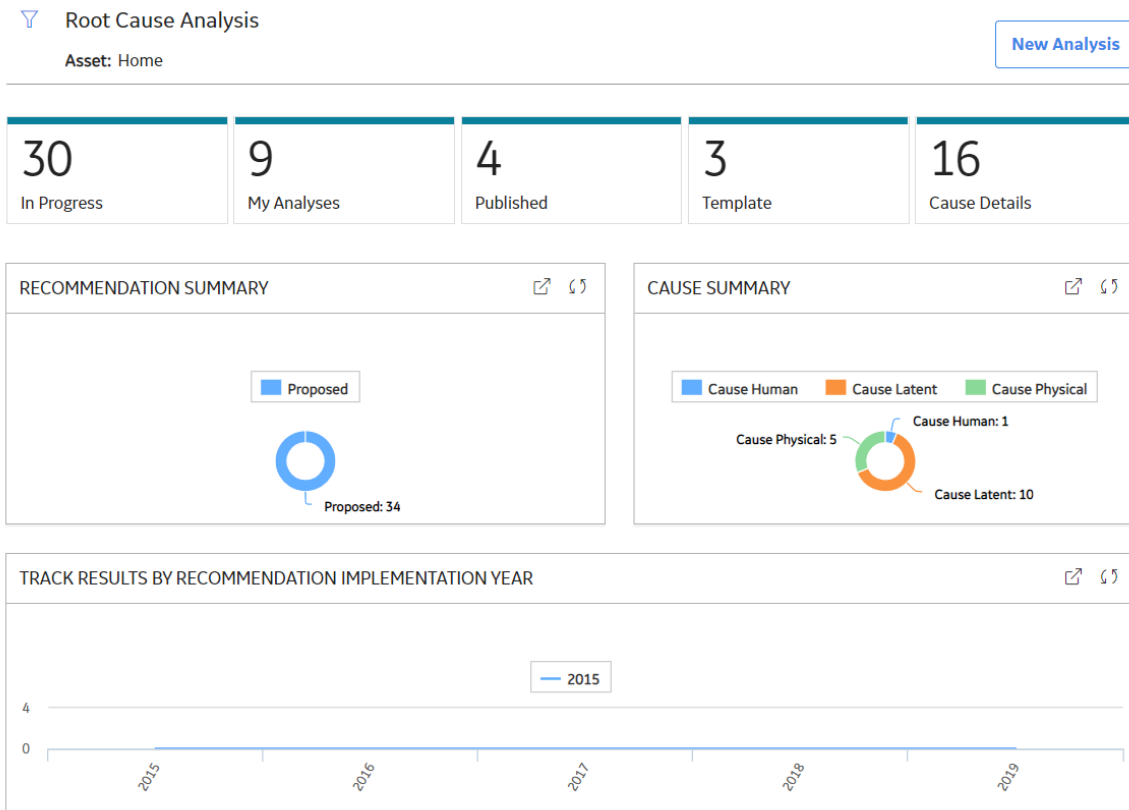

This topic describes how to access the **RCA Overview** page on which you can view all the information and perform various tasks related to Root Cause Analyses for various Asset Hierarchy Levels.

You can perform various tasks on this page based on the [Security Groups to which you are assigned](#).

Procedure

In the **Applications** menu, navigate to the **RELIABILITY** section, and then select **Root Cause Analysis**. The **RCA Overview** page appears.



The tabs at the top of the page summarize the number of items in each category. You can select a tab to view one of the following lists:

- **In Progress** : Displays Root Cause Analyses that have not yet been completed.
- **My Analyses** : Displays Root Cause Analyses to which you are assigned as a team member.
- **Published** : Displays Root Cause Analyses that have been completed and published.
- **Template** : Displays Root Cause Analyses that you can use to create new Root Cause Analyses. The Root Cause Analyses in the Template state are identical to the Root Cause Analyses that are in the In Progress state, except that they do not have an analysis team defined.
- **Cause Details** : Displays Root Cause Analyses that have their cause type defined in the Logic Tree. You can select the hyperlink for an analysis to view the details of the Root Cause Analysis. The Root Cause Analyses in the Template state are not included.

On the page, you can also view the following sections:


- **Recommendation Summary** graph: Displays the number of recommendations in each state.
- **Cause Summary** graph: Displays the number of Hypotheses, for the selected Asset Hierarchy Level and its children, that are related to each type of cause (i.e., Physical, Human, and Latent). The Root Cause Analyses in the Template state are not included.
- **Track Results by Recommendation Implementation Year** graph: Displays yearly performance of Asset Hierarchy levels on which RCA recommendations have been implemented. The chart displays sum of all the maintenance costs and production costs from the work history family associated with all the Asset Hierarchy levels related to the RCA recommendations that have been accomplished

within the year. The chart plots the maintenance costs of the Asset Hierarchy levels for the current year and the previous four years.

Note: Optionally, if you have an active license for PLA and access to the required PLA families, you can change this graph to one that includes the production costs associated with Production Loss Analysis (PLA). To do so, access the dashboard configuration for the **RCA Dashboard-V4** dashboard, which is stored in the Catalog folder `\\Public\Meridium\Modules\Failure Elimination\Dashboards`, and then modify the graph widget to reference the query `\\Public\Meridium\Modules\Failure Elimination\Queries\FE Dashboard Query - Track Result - Total for Graph-V4`.

Note: For more information, refer to the Dashboards section of the documentation.

While viewing any of the graphs on the **RCA Overview** page, you can select  to [customize the appearance of the graph](#).

By default, the hierarchy level is set to Home. You can filter the hierarchy level by selecting  in the upper-left corner of the page. By default, the Root Cause Analysis information that will appear on the page is related to an Asset and children of the Asset.

RCA Workflow

This workflow provides the basic, high-level steps for using Root Cause Analysis. The steps and links in this workflow do not necessarily reference every possible procedure.

1. [Define when an RCA should be performed](#).
2. [Create a Root Cause Analysis](#).
3. [Add Critical Success Factors to an RCA](#).
4. [Select the members of the RCA team](#).
5. [Modify the Team Charter in the **Definition** section](#).

Note: The user that completes tasks listed in Step 2 to Step 6 will be added to the RCA Team automatically as the Principal Analyst. After completing these steps, you can designate a different team member as the Principal Analyst. For information on designating a team member as a Principal Analyst, refer to the Teams documentation.

6. [Link the Assets on which the RCA is based](#).
7. [Link the RCA to Reference Documents](#), which contain reference material relevant to the analysis.
8. [Create RCA Preserve records](#) and assign them to team members.

Note: While the PROACT acronym lists the Preserve step first, the order in which you perform the associated task in APM can differ.

9. Create an [Event Diagram](#) or a [Logic Tree](#) to provide a visual representation of the data that was collected. You can create an Event Diagram or a Logic Tree depending on your requirement.

Note: Interaction with diagramming and design canvases is not available on touch-screen devices.

10. Create [RCA Recommendations](#), [communicate findings](#), and [generate reports](#) to present the team's conclusions to the decision makers in your organization. After you have successfully communicated the team's findings and the proposed recommendations have been approved, the recommendations should then be implemented within the organization.
11. [Create RCA Tracking Items](#) to track the success or failure of the solutions that were implemented.

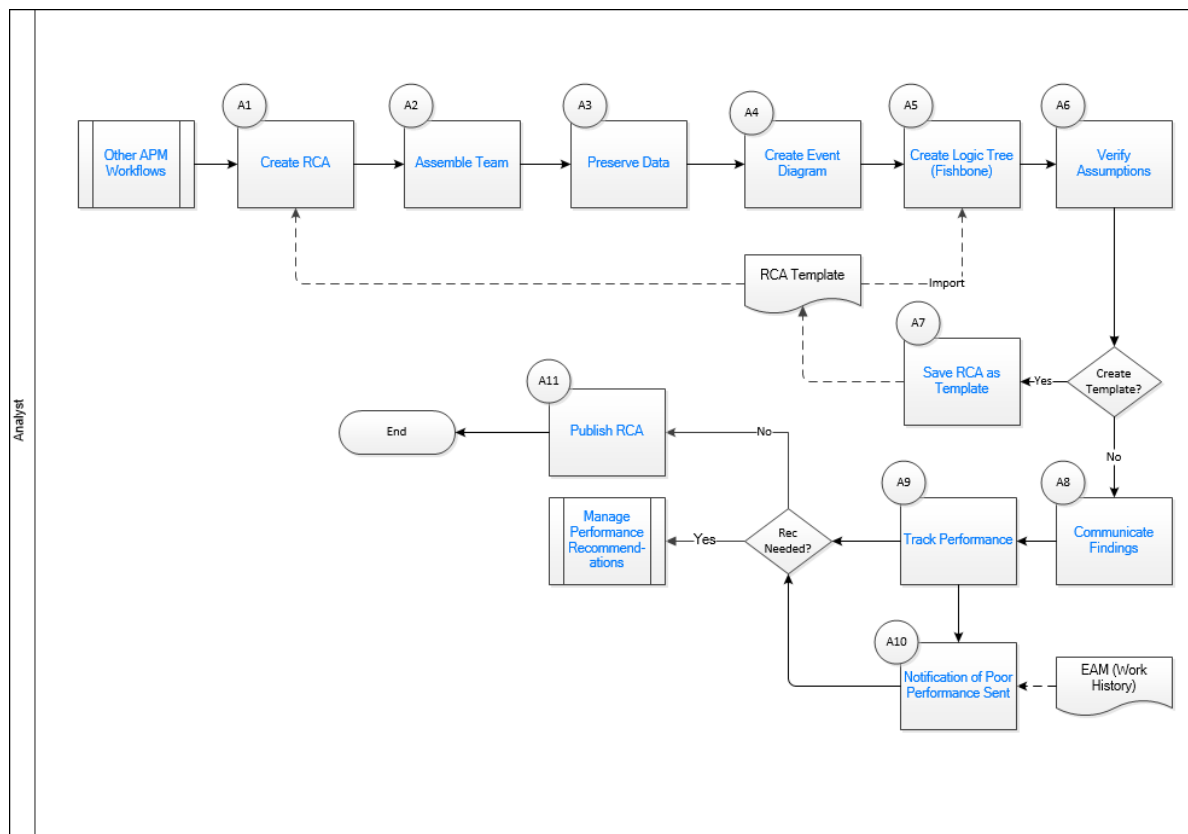

Create RCA

Persona: Analyst

Create a new RCA Analysis and save.

Assemble Team

Persona: Analyst

Assemble team members to perform an RCA.

Preserve Data

Persona: Analyst

Collect data for task assignments and task management.

Create Event Diagram

Persona: Analyst

Create an event diagram of all contributing factors that are possible causes of a failure event.

Create Logic Tree (Fishbone)

Persona: Analyst

View a complex logic diagram analysis of the event and all of the causes that led up to the event.

Verify Assumptions

Persona: Analyst

Prove or disprove a specific hypotheses based on detailed analysis.

Save RCA as Template

Persona: Analyst

Use an RCA to save as a template.

Communicate Findings

Persona: Analyst

Send the results of a comprehensive analysis report to one or more email recipients.

Track Performance

Persona: Analyst

Specify tracking parameters related to an asset and provide notifications when the specified criteria has been exceeded.

Notification of Poor Performance Sent

Persona: Analyst

When any of the conditions set as tracking items are met, the designated individuals are alerted of the poor performance via an automated email alert.

Publish RCA

Persona: Analyst

Publish the completed analysis to enable the RCA to be viewed by all RCA users.

Manage Performance Recommendations

Persona: Analyst

Create and manage recommendations designed to improve future performance.

Go to the Manage Performance Recommendations workflow.

Other Workflows

Persona: Analyst

Other Workflows provide production data from: SAP, EAM, Recommendations.

About Root Cause Analysis

This topic provides a listing of all overviews and high-level explanatory information to help you understand the Root Cause Analysis module.

About PROACT for Meridium

PROACT for Meridium is a comprehensive methodology that is used in the RCA module that allows you to conduct a root cause analysis.

The PROACT acronym consists of the following steps, where the letters that make up the acronym are capitalized:

- **P**reserve: Team members gather and information (i.e., failure data) about an Asset's failure.
- **O**rders: The Principal Analyst:
 - Defines the goals of the RCA.
 - Assembles the team members who will conduct the RCA.
- **A**nalyze: Team members review and analyze the available information and then any conclusions.
- **C**ommunicate: Team members submit, to the decision makers in the organization, their hypotheses about the cause of the failure and their recommendations for solutions to the failure.
- **T**rack: Team members track the success of the solutions that were implemented. A re-evaluation can be performed, as needed.

You can use these steps as a guideline for conducting a Root Cause Analysis in the RCA module, which consists of creating the data in APM that is necessary to complete these five steps of the PROACT for Meridium methodology and implement successful solutions.

Note: You are not required to complete these steps in the exact order that they are listed above. It is important, however, that all steps of the methodology be completed. For more information, see the [workflow for conducting a Root Cause Analysis](#).

About State Management in RCA

The Root Cause Analysis Module uses standard State Management functionality to manage RCA Analysis records.

Note: For more information, refer to the State Management section of the documentation.

Details

Actions that you take in the RCA module determine the state of an RCA Analysis. When you perform an action, the value in the State field changes automatically, which transitions the analysis from one state to another.

The state of an RCA Analysis record is stored in the State field, which is not included on any of the baseline datasheets that exist for the RCA Analysis family.

If State Management has been configured, then Root Cause Analyses can have one of the states in the following list.

Note: Only super users, MI PROACT Administrators and Principal members can change the state of an analysis.

- Not Started: Indicates that an RCA has not yet started.
- In Progress: Indicates that an RCA has not yet been completed.
- On Hold: Indicates that an RCA is on hold.
- Deferred: Indicates that an RCA has been postponed.
- Completed: Indicates that an RCA has been completed.

About Analysis Statuses in RCA

Actions that you take in the RCA module determine the state of an RCA Analysis. Statuses do not require configuration like State Management, and are used to track the progress of analyses.

Root Cause Analyses can have one of the states in the following list.

- In Progress: Indicates that an RCA has not yet been completed. Only APM users who are members of the RCA Team and members of the MI PROACT Administrator Security Group can view and modify an RCA when it is in the In Progress status. RCA Analyses will remain In Progress until the Principal Analyst publishes the analysis. Additionally, a Published RCA that is unpublished will return to the In Progress status.
- Published: Indicates that an RCA has been completed. After the RCA is complete, the Principal Analyst can publish the analysis, which will assign the Published status to the analysis and populate the Date Published field in the RCA Analysis record with the date on which it was published. When an RCA is published, APM users, regardless of whether they are members of the analysis team or not, will have read-only access to the RCA as long as they have the following security permissions:
 - View privileges to all RCA Analysis families, including the RCA Analysis Relationships and RCA System Relationships families.
 - Insert privileges on the RCA Analysis family.
 - Update privileges on the RCA Image family.

If a Published RCA is unpublished, the RCA will return to the In Progress state, but the value in the Date Published field will not be updated until the analysis is published again.

- Template: Indicates that an RCA has been produced from an existing analysis using the Produce Template link. RCA Analyses in the Template status are identical to Root Cause Analyses that are in the In Progress status, except that they do not have an analysis team defined. To modify or [transition analyses](#) with a Template status, you need to be a user with one of the following permissions.
 - Super Users, members of the MI PROACT Administrators Security Group, and Principal Analysts can [transition analyses to the Template state](#).
 - Super Users and members of the MI PROACT Administrators Security Group can modify an RCA Analysis that is in the Template state.

About Analysis Templates

An Analysis Template is a Root Cause Analysis that is in the Template state.

Analysis Templates are the same as other Root Cause Analyses except that they do not have team members assigned to them and they are always in the Template state (i.e., they never become published). The Analysis Templates can be created either from Root Cause Analyses in either the Published or In-Progress state and can be used for [creating Root Cause Analyses](#).

About Team Charter

The Team Charter is a statement that defines the goal that the RCA Team wants to achieve by conducting an RCA. The RCA Team can refer to the Team Charter throughout the analysis to determine if the goal is being achieved. A Team Charter is provided in the baseline APM database and appears in the **Team Charter** workspace of the [RCA Administrator page](#). An administrative user can specify the default Team Charter, which can be modified as needed.

About the RCA Team

The RCA team is the group of individuals who will complete the steps required for a comprehensive root cause analysis. Security permissions in the Root Cause Analysis module are based on family-level privileges and a user's role within a given Root Cause Analysis. Root Cause Analysis users who are members of the RCA Team will have one of the following RCA team member roles:

- Principal Analyst: The user who is responsible for facilitating and coordinating the Root Cause Analysis.
- Analysis Team Member: Any user who is a member of an RCA Team.

You can add APM users and non-APM users to the RCA Team.

- APM users will have an existing APM Security User account and an associated Human Resource that is created automatically when the Security User account is created.
- Non-APM users will not have a APM Security User account. To add a non-APM user to the RCA Team, you first need to create a Human Resource for that user.

When you add new members to the RCA Team, an RCA Team Member is created automatically and linked to the Root Cause Analysis and the individual's Human Resource. If the same team member is linked to multiple analyses, an RCA Team Member will exist for each RCA team in which it is a member. The RCA Team Member stores the RCA Team member's role (i.e., Team Member or Principal Analyst).

RCA Team Members and Security

In RCA, Security Group membership is used in conjunction with a user's role within a given analysis to determine what that user can and cannot do with that analysis. A given team member's role determines the [security privileges](#) that the user has in Root Cause Analysis. After you add a new team member to the RCA Team, that user will inherit the [security privileges](#) associated with the user's team member role (e.g., Principal Analyst).

Each analysis has:

- A Principal Analyst who can perform all functions related to the analysis.
- Analysis team members, who can perform most functions related to analysis but are restricted from performing some tasks that are reserved for the Principal Analyst.
- Viewers, who can only view the analysis.

For a complete description of the functions that are allowed and not allowed based on a user's role within an analysis, see the [RCA Security Groups](#). Privileges granted through roles are done through data filters that are defined on the baseline Analysis family for Root Cause Analyses.

About Assets in RCA

Assets are Equipment and Functional Locations that you can link to a Root Cause Analysis. Each RCA is linked to one or more Equipment and Functional Locations to indicate the equipment and locations that are experiencing problems.

You can link only Equipments, only Functional Locations, or both to a Root Cause Analysis. The type of asset to which you link depends on the type of situation that you are analyzing. Consider the following examples.

1. You want to run a Root Cause Analysis on a pump, which is always located in the same place. You link the pump's Equipment to the Root Cause Analysis.
2. You want to run a Root Cause Analysis on an incident that occurred at a specific plant and you aren't sure which pump was involved. You link the plant's Functional Location to the Root Cause Analysis.
3. You want to run a Root Cause Analysis on a pump that was previously located in another plant and has been installed in a new plant. You link both the pump's Equipment (which is already linked to the new plant's Functional Location) and the old plant's Functional Location to the Root Cause Analysis.
4. You want to run a Root Cause Analysis involving multiple pumps that are all experiencing similar failures. You link multiple Equipments to the same Root Cause Analysis.

Define When a Root Cause Analysis Should be Performed

Before you begin conducting a Root Cause Analysis using the Root Cause Analysis module, you should determine which events require further investigation through a Root Cause Analysis. This involves defining criteria that standardizes when a Root Cause Analysis should always be performed.

The criteria to perform a Root Cause Analysis should be defined according to the needs and resources within your organization. For instance, the criteria can be based strictly on the data collected in Failures. For example, the criteria might be that a Root Cause Analysis is automatically performed when an asset fails more than two times in a 12-month period. The criteria can also be less restrictive, allowing an area manager or reliability engineer to initiate a Root Cause Analysis even if a failure does not meet the standard criteria.

Regardless of the specific criteria that you use, your goal should be to define criteria that will allow personnel to know when a Root Cause Analysis should always be conducted, ensuring that failure events are analyzed in a consistent and methodical way.

About Critical Success Factors (CSFs)

Critical Success Factors are elements of a Root Cause Analysis that allow the analysis team to evaluate whether or not the analysis effort has been successful. The effort is considered to be successful if the analysis team adheres to and meets the standards defined by the Critical Success Factors. The Root Cause Analysis Team can define Critical Success Factors that are specific to a given Root Cause Analysis or that are more generic to the work process.

RCA uses the following two types of Critical Success Factors:

- **Default CSFs:** RCA Critical Success Factors that are available for use in all Root Cause Analyses. Default Critical Success Factors are stored as system preferences and appear in the **Critical Success Factors** workspace on the [RCA Administrator page](#), where an administrative user can modify them and define their own default Critical Success Factors. Default Critical Success Factors are not stored until they are added to an RCA. When a default Critical Success Factor is added, a new Critical Success Factor is created and populated automatically with the **Default CSF** text, then linked to the Root Cause Analysis.
- **Custom CSFs:** RCA Critical Success Factors that are created for specific Root Cause Analyses. You can define custom Critical Success Factors for each Root Cause Analysis via the **Critical Success Factors** section. Custom Critical Success Factors are defined for a single Root Cause Analysis and stored in RCA Critical Success Factors. When Custom Critical Success Factors are created for a Root Cause Analysis, a new RCA Critical Success Factor is created and linked to the Root Cause Analysis.

You can select one or more Critical Success Factor from the default Critical Success Factors, create a custom Critical Success Factor, or you can choose not to define a Critical Success Factor.





About Preserve Failure Data

In a Root Cause Analysis, preserving failure data involves collecting a wide range of information related to the failure that the team will analyze. The collected data is stored in RCA Preserve Item records, which contain task-related data for the collection of the failure data. The RCA Preserve Item records are tasks that are assigned to the team member who should collect the failure data specified by a certain date. For example, an RCA Preserve Item may contain a task to collect all the broken pieces of a piece of equipment.

The 5 P's

When you create an RCA Preserve Item, the type of data that you want a member of the Root Cause Analysis Team to collect is identified by one of the following categories, known as the 5 P's:

- **People:** Indicates that human witnesses should be questioned about the incident. Witnesses might include the person who is responsible for the maintenance of the piece of equipment or location associated with the failure event, the operator, or even the stock room attendant.
- **Parts:** Indicates that physical pieces of the equipment should be collected (i.e., the broken pieces). This may also include collecting a functional piece of equipment to test against the broken one.
- **Paper:** Indicates that any data or information that exists about the piece of equipment or location should be gathered. This could include recent performance reports, schedules, APM data, specifications, and so on.
- **Position:** Indicates that the environment in which the piece of equipment or location exists should be documented and considered. This could include, for example, the temperature of the room at the time of the incident or the proximity of one piece of equipment or location to another.
- **Paradigms:** Indicates that any trends or common assumptions about the cause of the incident should be considered. The intent of noting these paradigms is to remove this assumption from the investigation (i.e., remove any bias from the analysis).



About 5 Whys Analyses

A 5 Whys Analysis is a simplified, interrogative analysis that explores the cause-and-effect relationships of a failure. The goal of this analysis is to determine the root cause of an issue by repeating the question of "why." Each time a "why" is answered, a new question can be formed to determine the root cause of an issue.

By asking a series of five questions, you can avoid making assumptions and falling into logic traps. Instead, you can see a direct line of cause-and-effect relationships that determines how an issue was reached and the root cause of that issue.

Pump Failure		
A pump has failed, and a system shutdown has occurred. Using the 5 Whys methodology, you can ask the following questions to find out why:		
Question	Why	Reason
1	Why did the system shutdown?	Safety cutout applied when the cooling pump failed.
2	Why did the pump fail?	The bearing seized.
3	Why did the bearing seize?	The bearing was dry and overheated.
4	Why was the bearing dry and overheated?	Scheduled lubrication inspections were not completed.
5	Why weren't the scheduled inspections completed?	The inspection schedule is missing the appropriate tasks for pump lubrication.
For each question in the Why column, the answer in the Reason helps to generate the following Why, eventually leading to the root cause of an issue. Based on this table, you can see that the system shutdown is the direct result of incomplete inspections for pump lubrication.

About Event Diagram

In an RCA, analyzing data involves compiling the information that has been collected so far in the Root Cause Analysis and representing it visually to facilitate discussion. An Event Diagram is an organizational tool that you can use to diagram a sequence of events, which are possible causes of a failure event.

The Event Diagram lets you represent visually the events that are associated with a failure and the cause-and-effect relationships that may have led to a failure event. The Event Diagram depicts how the events affect each other and enables you to identify possible work process issues. Each event is represented by a labeled icon, called a node. You can add nodes to the Failure Event node that represent components of the RCA. For example, if you define the Failure Event node as a fire, in the Event Diagram you can add to the Failure Event node upstream nodes that depict the chain of events that preceded the failure event.

The following list provides the types of nodes that you can use in an Event Diagram:

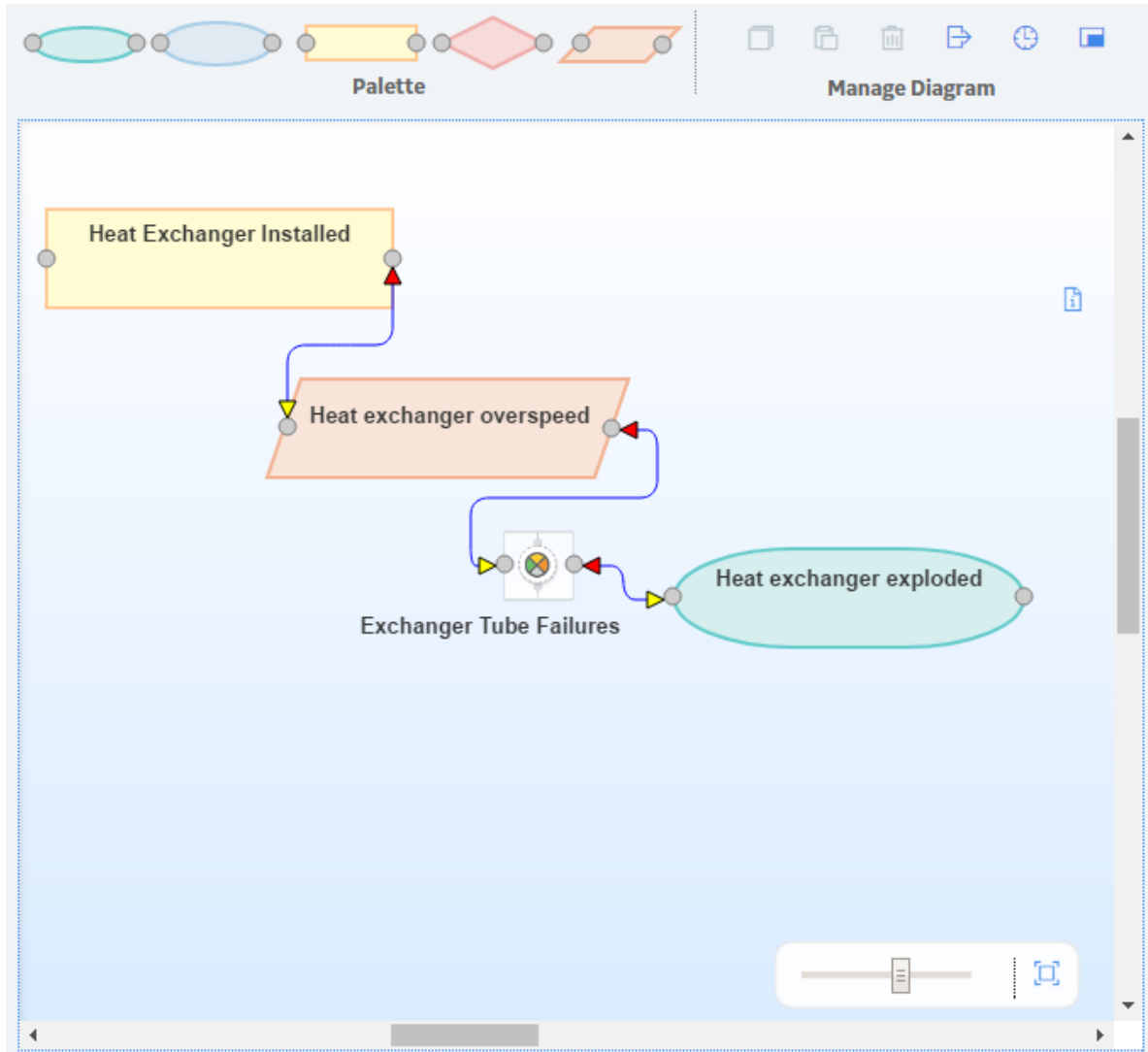
Node Icon	Node Name	Can be used to represent...
	Start/Finish	A step that marks the starting point or the ending point of the event.
	References	A printed document or report.
	Process	A single step or an entire sub-process within a larger process.
	Decision	A decision or branching point.
	Operation	Material or information entering or leaving the system, such as customer order (input) or a product (output).

You can create connections between the nodes in the Event Diagram to establish a relationship between the nodes. Each node in the diagram canvas has two ports that are used for connecting nodes to another node. Each port is designated by a circle on the right and left of the node. You can initiate a connection only from right circle (output port) of the predecessor node to the left circle (input port) of the successor node. You can create as many connections as you need to build the Event Diagram. More than one connector can be attached to the same port of a node, allowing you to create parallel events. As you connect the nodes to build the Event Diagram, links are created between the items using a predecessor-successor relationship definition that exists between them.

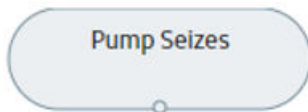
Note: The predecessor is the node that precedes the node that is currently selected in the Event Diagram. The successor is the node that succeeds the node that is currently selected in the Event Diagram.

About Failure Events

The failure event is a short description of the problem that you and your team are analyzing. Your team could be analyzing a failure event that comprises several failures over a specified period of time, or one failure (e.g., a larger event, such as a fire). The first time that you access the **Event Diagram** workspace or the **Logic Tree** workspace for a given RCA, you will be prompted to define the failure event in an RCA Event, which will be used as the Failure Event node. The following image shows an example of a completed RCA Event.



Each RCA will have one Failure Event node, which will always appear at the root level of the [Logic Tree](#) hierarchy and as the first node in the [Event Diagram](#). For example, the following image shows the Failure Event node as it appears in the Logic Tree in our [Cooling Water Pump example](#).



You cannot remove the Failure Event node from the Logic Tree or the Event Diagram. You can, however, modify the RCA Event, as needed.

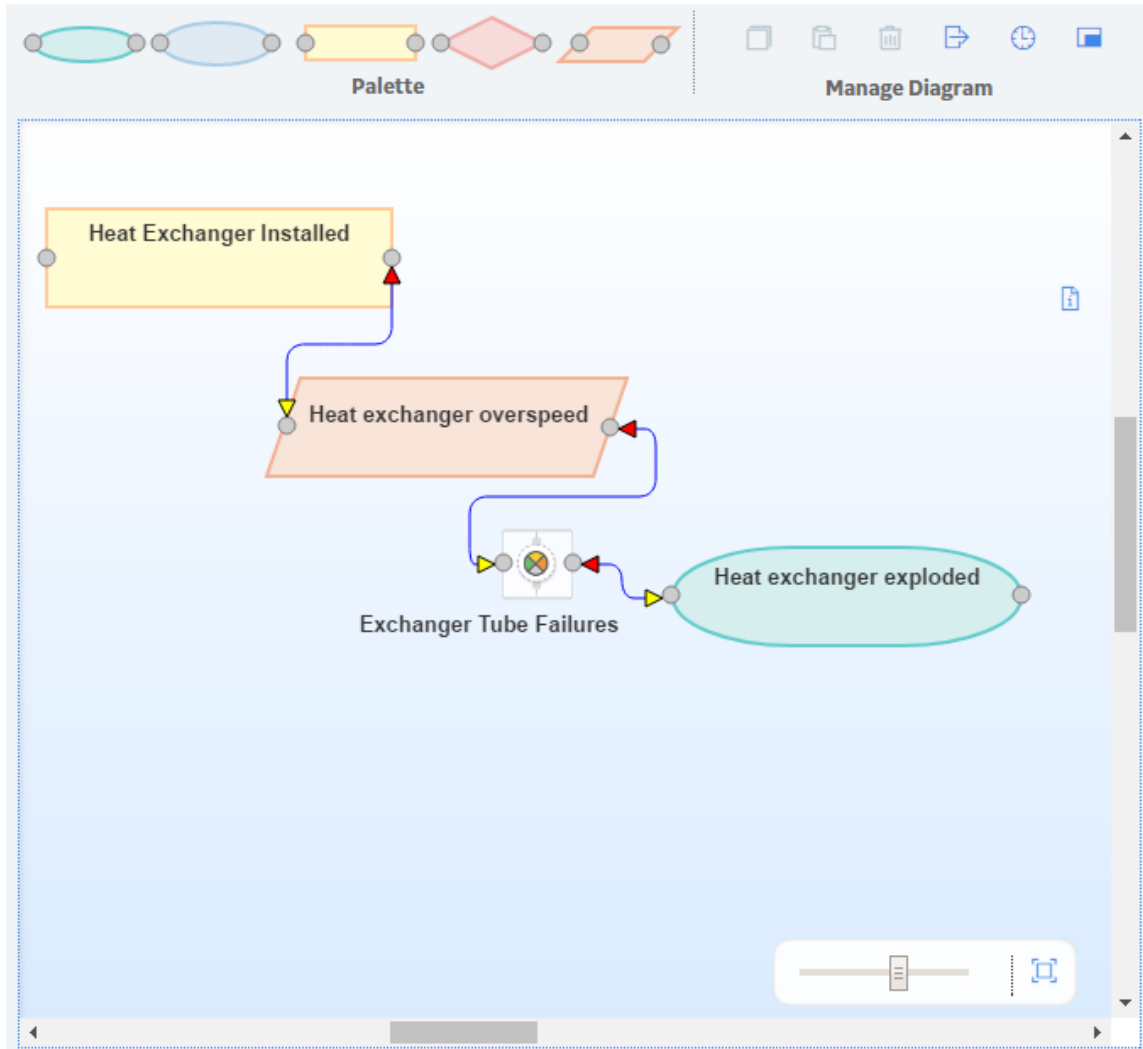

About the Event Timeline

In Root Cause Analysis, a Failure Event is often the result of a sequence of contributing events. The Event Timeline is an organizational tool that enables RCA Team Members to collate and display Event data in a form that provides a visual representation of the timeline in which a sequence of contributing events have played out.

Once you have added a primary Event to the Event Timeline, you can add Secondary Events to create a more detailed representation of events associated with the failure.



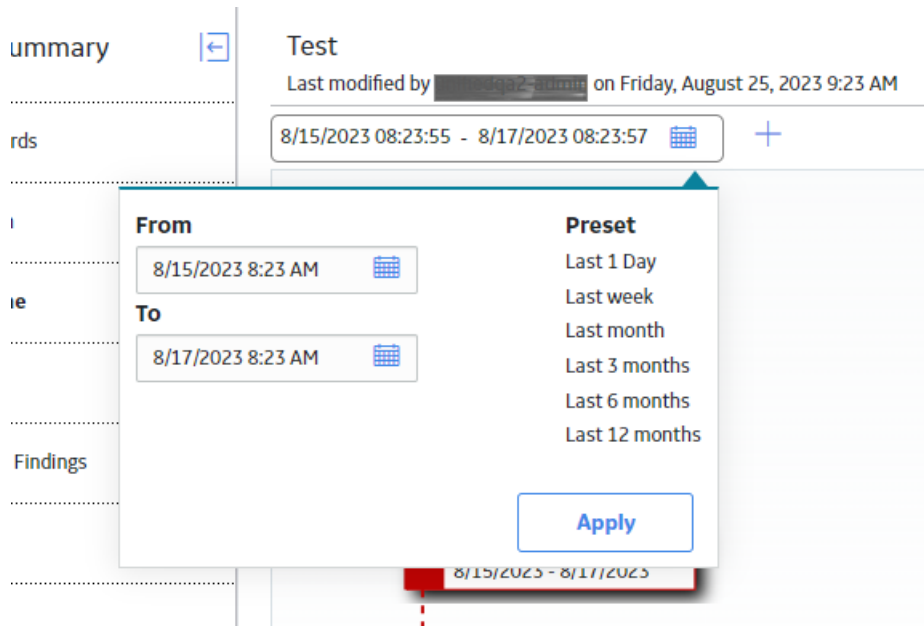





About Logic Tree

In a Root Cause Analysis, analyzing data involves compiling the information that has been collected so far in the Root Cause Analysis and representing it visually to facilitate discussion. A Logic Tree is an organizational tool that you can use to diagram all the possible causes of a [failure event](#).

Details

The Logic Tree lets you represent visually the events that are associated with a failure and the cause-and-effect relationships that may have led to a failure event. The structure of the Logic Tree is hierarchical so that you can easily reference which event caused which effect. Each cause or effect is represented by a labeled icon called a node. You can add nodes to the Failure Event node that represent components of the Root Cause Analysis. For example, if you define the Failure Event node as a fire, in the Logic Tree, you would add to the Failure Event node downstream nodes that represent all the possible causes for the failure event.

The following table provides the types of nodes that you can use in a Logic Tree Diagram.

Icon	Node
	Failure Event
	Failure Mode
	Hypothesis
	Logic Gate

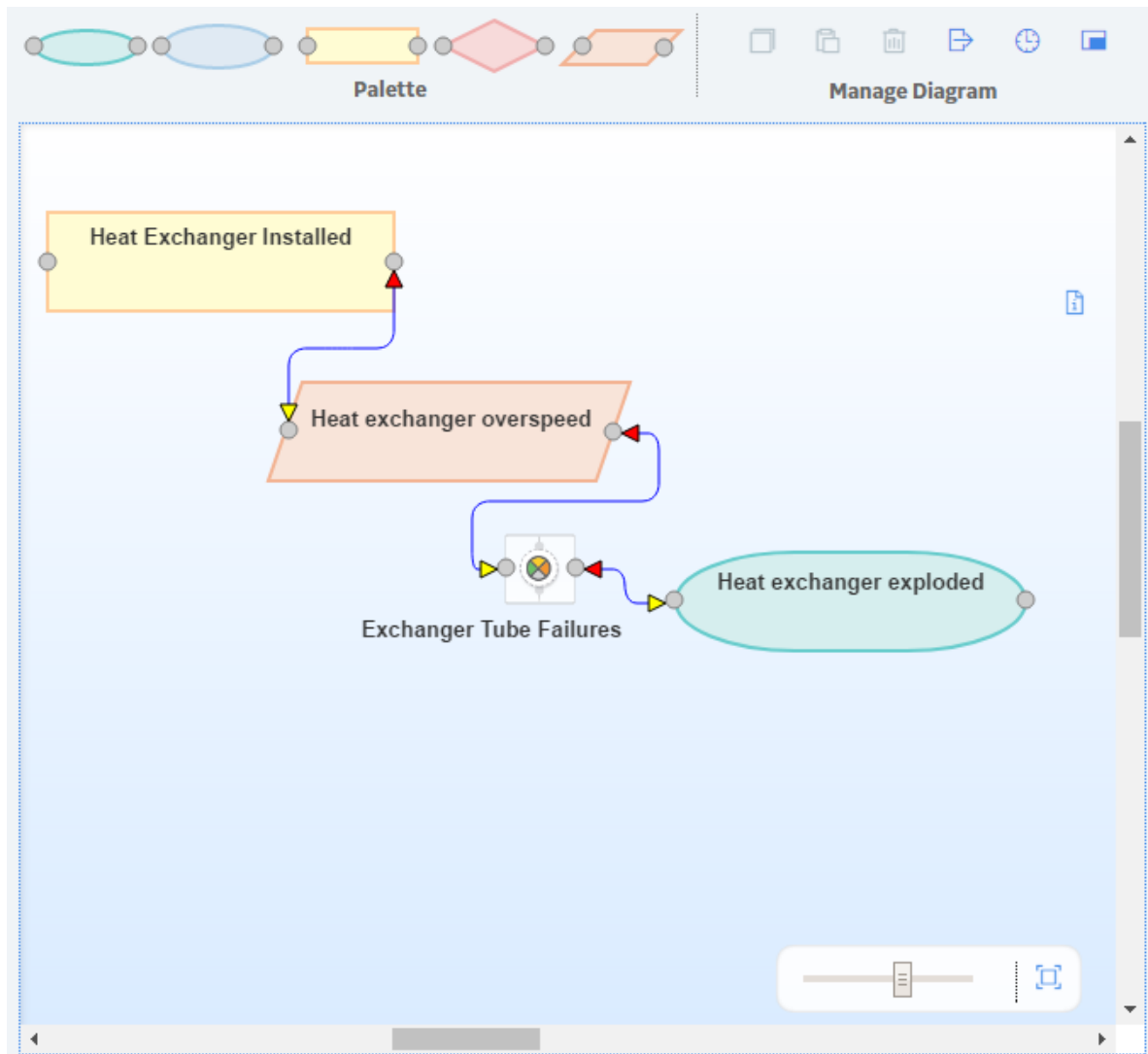
Each node has an associated node, which participates in a predecessor-successor relationship. For example, each Failure Mode node that appears in the Logic Tree has an associated RCA Failure Mode that is linked to the root RCA Event. Additionally, for each Hypothesis node that appears in the Logic Tree, an associated RCA Hypothesis exists that is linked to the predecessor RCA Failure Mode and the root RCA Event. Additionally, when you add a node to the Logic Tree, a link is created between that node and the RCA.

The following image illustrates the basic structure of the Logic Tree.

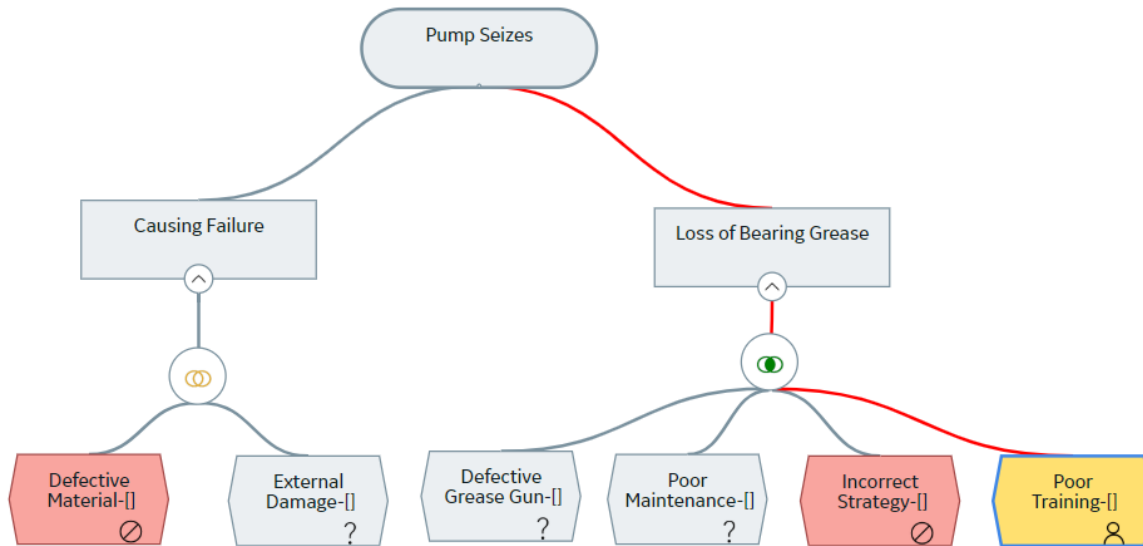
Difference Between an Event Diagram and a Logic Tree

The Event Diagram can depict the cause-and-effect of events that led to the failure event and post-failure activities. The Logic Tree, however, can depict, starting with the failure event, possible causes and hypotheses related to the event itself.

The Event Diagram enables the RCA Team to view and organize the chain of events prior to the failure event and identify possible work process issues. The following image shows an Event Diagram that was created in the **Event Diagram** workspace.



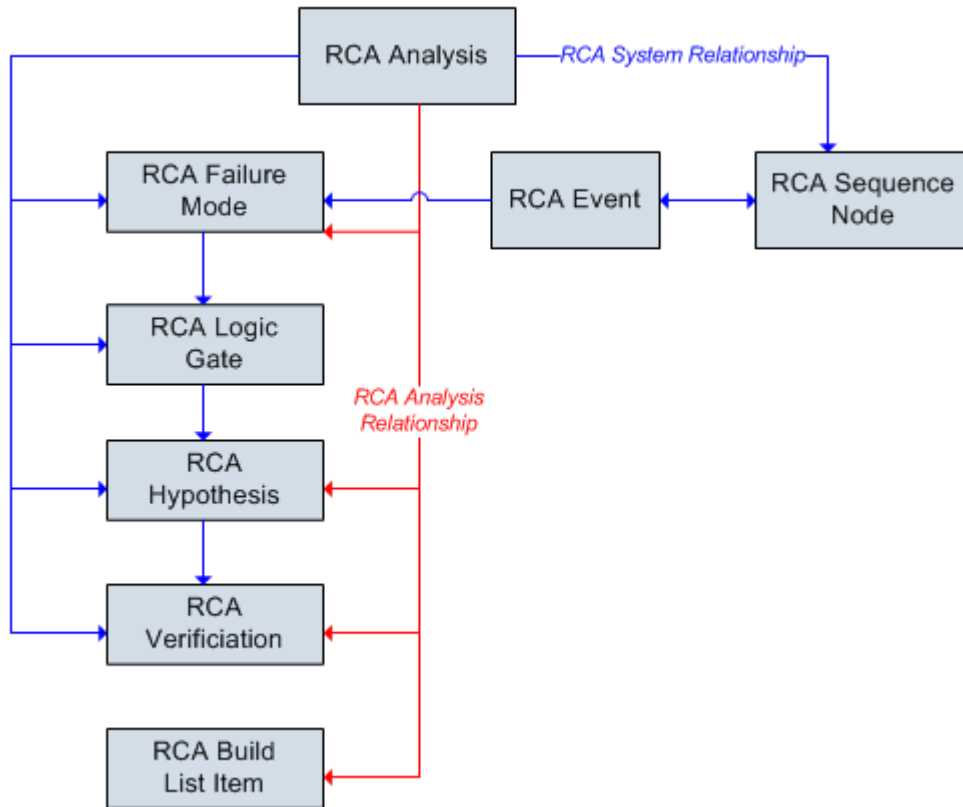
The Logic Tree can depict, starting with the failure event, possible causes and hypotheses related to the event itself. The Logic Tree enables the RCA Team to organize and discussion points on the possible causes of the failure event. The following image shows a Logic Tree that was created using options in the **Logic Tree** workspace.



Event Diagram and Logic Tree Data Model

An Event Diagram and a Logic Tree consist of an RCA Event and all the records that are linked to it directly or indirectly. For example, after you define the failure event, you can create RCA Failure Modes to link to the RCA Event, and then you can link RCA Hypothesis to the RCA Failure Modes, and so on.

The following image shows the entity families and relationship families that are used to create an Event Diagram and a Logic Tree in Root Cause Analysis. The Logic Tree and the Event Diagram share an RCA Event. The RCA Sequence Node family is used only by the Event Diagram. All of the other families are used by the Logic Tree.



Records in the RCA Logic Gate family can be linked to others in the RCA Logic Gate family. Additionally, records in the RCA Sequence Node family can be linked to others in the RCA Sequence Node family.

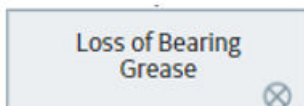
In addition to the relationships that appear in the images, the following families can be linked to records in the RCA Reference Document family through a relationship definition on the Has Reference Documents family:

- RCA Event
- RCA Hypothesis
- RCA Logic Gate

About Failure Modes

A failure mode is a possible cause associated with the failure event. The failure mode is represented by a node, called the Failure Mode node, which appears below the Failure Event node. When you add a Failure Mode node to the Logic Tree, you are defining the RCA Failure Mode. When you define an RCA Failure Mode, a link is created between the RCA Failure Mode and the root RCA Event and between the RCA Failure Mode and the RCA.

Failure Mode nodes exist on the second level of the tree, under the Failure Event node. Multiple Failure Mode nodes can be linked to the Failure Event node. The following image shows an example of how a Failure Mode node will look in the Logic Tree.



A given failure event can have multiple failure modes. For example, the image shows the failure modes from our [Cooling Water Pump failure](#) example. The Failure Event node (i.e., the overheated pump) is associated with the following Failure Mode nodes:

- No Spare Parts: There were no spare parts when the pump overheated, which caused the pump to be down for a longer amount of time and a greater loss of production. This failure mode did not cause the failure, so there are no hypotheses associated with it, but it is included as part of the failure event.
- Motor tripped due to high temperature: This failure was the cause of the overheated pump event. There are additional hypotheses associated with this node so that the cause of the event can be determined.

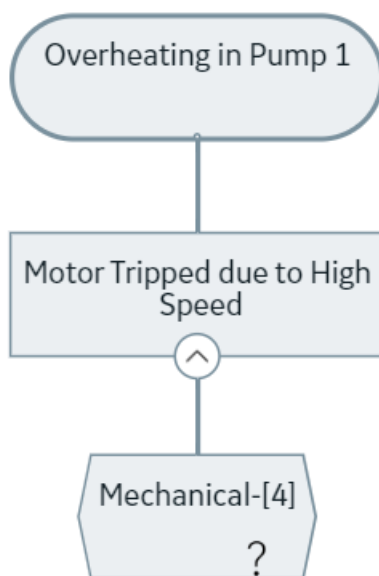
About Hypotheses

By definition, a hypothesis is a tentative assumption intended to explain certain facts or observations. For a Root Cause Analysis, a hypothesis represents a theory about the root cause of a failure event. RCA Hypotheses are then assigned a state that indicates the validity of the hypothesis.

Details

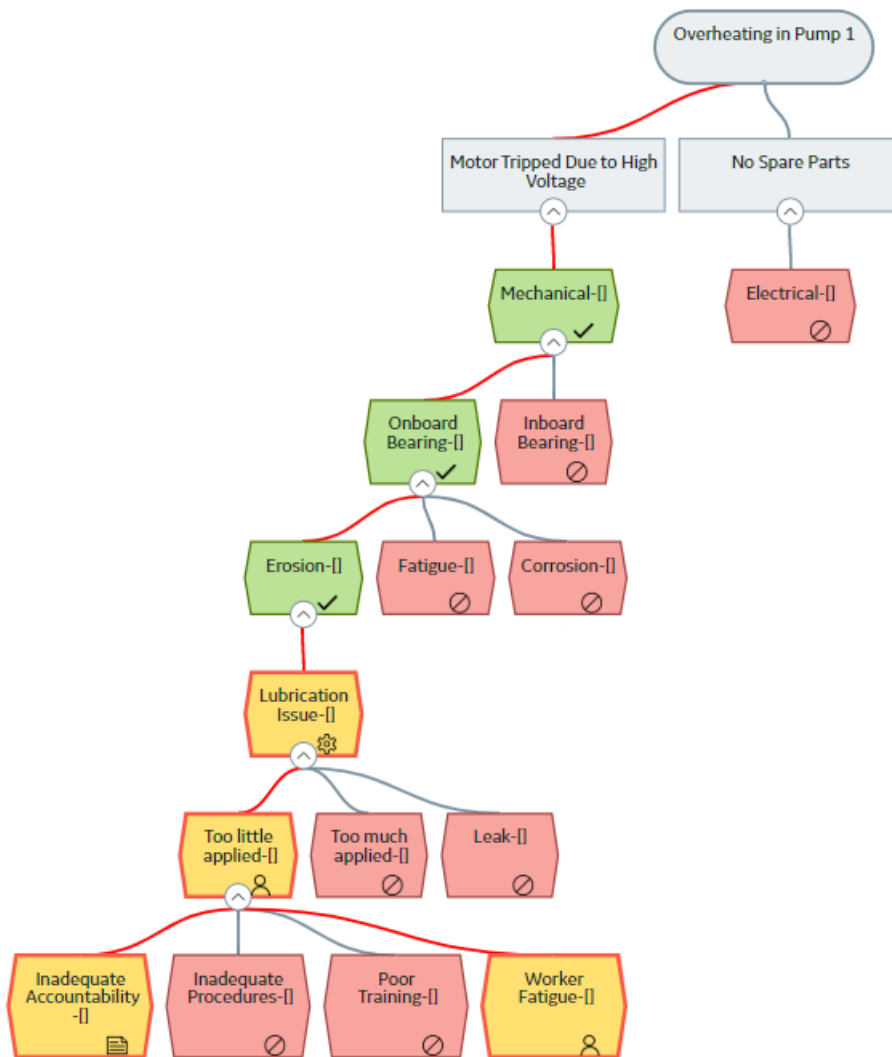
In the Logic Tree, a hypothesis is represented by a Hypothesis node, which is defined in an associated RCA Hypothesis. Hypothesis nodes can appear below Failure Mode nodes and other Hypothesis nodes in the Logic Tree. When you add a Hypothesis node to the Logic Tree, a link is created between the RCA Hypothesis and the RCA. A link is also created between the RCA Hypothesis and either the RCA Failure Mode or the predecessor RCA Hypothesis.

The following image shows an example of how a Hypothesis node and the associated RCA Hypothesis will look in the Logic Tree when it is first created.



To the right of the label that you assign to the Hypothesis node, a number appears, indicating the level of confidence that the team has in the hypothesis being true. After a given RCA Hypothesis has been created, the team can create an RCA Verification to test the hypothesis. The team will then change [the state of the RCA Hypothesis](#) according to the results of the RCA Verification.

You can define multiple Hypothesis nodes for any RCA Failure Mode or RCA Hypothesis, meaning that multiple factors could be responsible for a given cause. For example, a lubrication issue may cause a cooling water pump to overheat, but that lubrication issue was caused by an operator who did not apply enough lubricant, which was caused by inadequate accountability of workers. In this case, the lubrication issue is a physical cause, too little lubrication applied is a human cause, and the latent root cause is the inadequate accountability of workers. The following image shows how this scenario would appear in the Logic Tree.



About Hypothesis States

RCA Hypotheses are assigned a state that indicates the validity of the hypothesis. When a Hypothesis node is first created, it is assigned the Hypothesis state by default.

Tip: You can add your own Hypothesis state and assign it an image by updating the RCA Hypothesis State System Code Table in Configuration Manager.





After the hypothesis has been tested through the completion of an RCA Verification, the state of the Hypothesis node can then be changed to True or Not True. If a hypothesis is proven to be incorrect, after



you change the Hypothesis state to Not True, you are finished working with that hypothesis. If a hypothesis is proven to be true and you change the Hypothesis state to True, you can:

- Create additional RCA Hypothesis records that provide further information on a root cause and link them to the RCA Hypothesis.
- Create RCA Verifications to test the additional hypotheses, determine if the hypotheses are true or not true, and then change the state of the associated RCA Hypothesis records accordingly.
- Create additional RCA Verifications to test the hypothesis to further **identify the root cause as physical, human, or latent**.

After the root cause has been identified, you can change the state of the associated RCA Hypothesis to indicate your conclusions (i.e., Cause Human, Cause Latent, or Cause Physical).

When you **change the state of a Hypothesis node**, the node icon changes to indicate the new state. The following table describes all the possible states of an RCA Hypothesis and how the associated Hypothesis node will appear in the Logic Tree.

Hypothesis Node	Hypothesis State	Description	For example, the team may determine that:
	Hypothesis	The hypothesis is proposed and no conclusions can be drawn at this point. This is the default state.	The piece of equipment may have failed due to a pressure leak.
	Hypothesis True	The hypothesis has been tested and proven to be correct. Further conclusions can be drawn.	The piece of equipment failed due to a pressure leak.
	Hypothesis Not True	The hypothesis has been tested and proven to be incorrect. No further conclusions can be drawn.	The piece of equipment did not fail due to a pressure leak.
	Cause Human	The hypothesis has been proven correct and further testing has revealed that the root cause of the Failure Event was caused by human interaction.	The operator failed to increase the pressure when it reached the critical level, therefore causing a pressure leak and the failure.



Hypothesis Node	Hypothesis State	Description	For example, the team may determine that:
	Cause Latent	The hypothesis has been proven correct and further testing has revealed that the root cause of the Failure Event was caused by flaw(s) in procedure or the system that caused incorrect decisions to be made. This is often due to poor data or communication between individuals within the organization. In the vast majority of events, there will be at least one latent cause.	Management failed to adhere to the recommended safety guidelines for the piece of equipment, thus the operator failed to increase the pressure when it reached the critical level, causing the pressure leak and the failure.
	Cause Physical	The hypothesis has been proven correct, and further testing has revealed that the root cause of the Failure Event was caused by a physical piece of equipment.	The seals on the pressure relief valve are worn and require replacement, which caused the pressure leak and the failure.

About Verification

A verification is a task to prove or disprove a hypothesis. An RCA Verification contains the task-related information required to verify a hypothesis. The RCA Verifications are assigned to team members, similar to the way in which RCA Preserve Records are assigned. For example, if you wanted to verify whether a pump overheated because of a mechanical or electrical problem, you would need to inspect the pump's wiring.

About Logic Gates

You can add logic gates to the Logic Tree to define a connection between nodes. A logic gate is defined in an RCA Logic Gate and is represented in the Logic Tree by a Logic Gate node. You can use Logic Gate nodes to add Boolean logic between nodes (i.e., AND and OR statements). The AND Logic Gate is

represented by the  symbol in the Logic Tree. The OR Logic Gate is represented by the  symbol in the Logic Tree.

Details

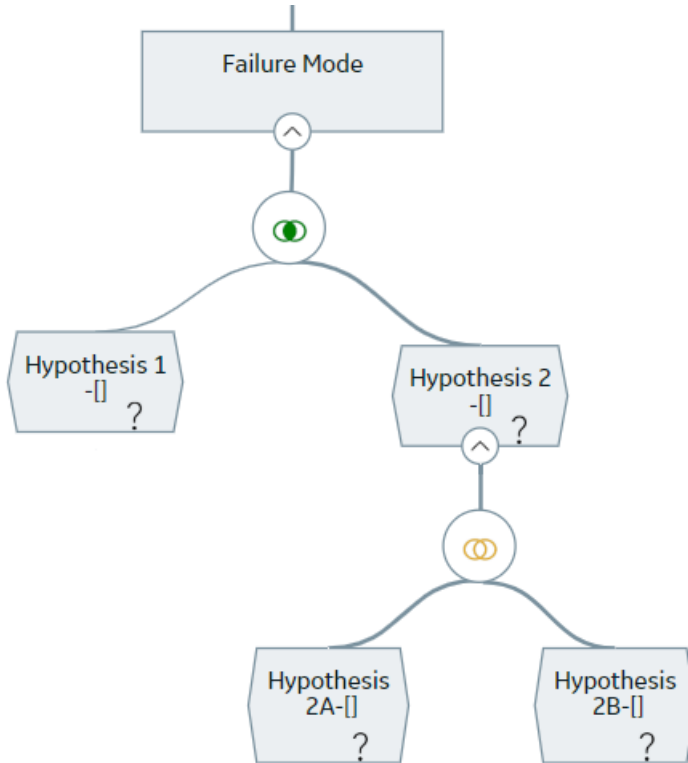
Adding a Logic Gate node between other nodes in the Logic Tree indicates a conditional relationship between the nodes, which you can define in the description fields in the RCA Logic Gate. These conditional relationships are defined in logical statements (e.g., if B is true, then A is true).

When two or more hypotheses are linked to a common predecessor node, the hypotheses nodes are by default connected using the OR Logic Gates, whether the Logic Gates are visible or not.

Example: Logic Gates

Suppose that you want to indicate in the Logic Tree that Failure Mode is true only if Hypothesis 1 and Hypothesis 2 or Hypothesis 2A and Hypothesis 2B are true.

You would organize the nodes in the Logic Tree as shown in the following image.




Access the Logic Tree Diagram

Track and Reevaluate the Analysis Results

After your team's findings have been communicated successfully to the necessary individuals in your organization, the next step in the PROACT workflow is to track the effectiveness of your recommendations through RCA Tracking Items. The goal of tracking recommendations is to make sure that the recommendation that was implemented has produced the required results. Depending on the results, you may need to reevaluate the solution that was implemented to address the underlying issues.

During the tracking process, the team should decide on a set of conditions on which reevaluation notifications should be based. The Principal Analyst should specify these conditions in the associated fields in the RCA Tracking Item. These notifications should be based on event criteria.

Criteria that is event-based includes a number of failure events and/or the failure cost that the piece of equipment or location has incurred after the implementation of a recommendation. When the criteria defined in the RCA Tracking Item is exceeded, the RCA Tracking Item will be updated automatically to a Reevaluate status, and an email reminder will notify the responsible party to reexamine the recommendation.

About Recommendations

A recommendation is a suggested solution for preventing or lessening the impact of future failures for the piece of equipment or location that the RCA Team is analyzing, such as making changes to maintenance schedules or providing additional training to operators. The RCA Team should develop these solutions based on the evidence that was collected and the conclusions that were drawn in the Preserve and Analyze steps of the Root Cause Analysis.

RCA Recommendations store the details of the team's recommendation and provide functionality that lets you send alert emails to a human resource for the person responsible for implementing the recommendation. In this way, RCA Recommendations represent tasks assigned to a person with human resource.

After the recommendation is completed, the value in the Status field of the RCA Recommendation can be marked as Implemented. The success of the implemented recommendation, however, should continue to be tracked. If the piece of equipment or location continues to fail after the recommendation has been implemented, the RCA Recommendation can be flagged for reevaluation.

About Equipment, Locations, and RCA Recommendations

The details of the recommendations and the progress associated with getting the recommendation approved and implemented can be tracked using fields in RCA Recommendations records. When you create an RCA Recommendation, a link is created between the RCA Recommendation and the Root Cause Analysis. You can then choose to link the RCA Recommendation to an Equipment or Functional Location. Depending on the nature of the recommendation, RCA Recommendations may or may not be linked to the same Equipment and Functional Locations that are linked to the Root Cause Analysis.

For example, suppose you created a Root Cause Analysis for a piece of equipment called Pump 1 that was shutting down more frequently than normal. You find that the pump is one of several pumps that are more than 10 years old. You create an RCA Recommendation to increase inspection rounds for Pump 1. Although the Root Cause Analysis was performed for Pump 1, another similar pump, Pump 2, is the same age. You can create a new RCA Recommendation and populate the value in the Equipment ID field to Pump 2 so that the same recommendation can be applied.

Furthermore, if the Equipment Pump 1 is already linked to the Functional Location Row 12, you can change the value in the Functional Location ID field of the RCA Recommendation from Row 12 to reflect a

higher level Functional Location, such as Statesville Plant. This value can serve as an indicator that pumps located at the Statesville Plant are older than other plants, which is more relevant than the information that Pump 1 is located in a certain row.


Workflow for Proposing and Implementing Recommendations

RCA and the fields in the RCA Recommendation facilitate the following general workflow for proposing and implementing recommendations:

1. After a hypothesis is proven true and a root cause is identified, the RCA Team discusses possible solutions.
2. After a recommendation has been developed, the analysis team creates an RCA Recommendation from the analysis. When the RCA Recommendation is created, the value in the Status field is populated by default.
3. The Analysis Team defines the details of the recommendation in the RCA Recommendation. If the recommendation is specific to a piece of equipment or location, the Analysis Team can define values in the Equipment ID and Functional Location ID fields to link the RCA Recommendation to the Equipment or Functional Locations that represents that equipment and locations.
4. After the RCA Recommendation is created to track the progress of the recommendation, an RCA Team member proposes the recommended solution to the decision makers in your organization using the details stored in the RCA Recommendation.
5. Your organization makes decisions about the recommendation (e.g., approve or reject), and the necessary fields (including the Status field) in the RCA Recommendation are updated to reflect these decisions.
6. After a recommendation has been approved (i.e., the value in the Status field is changed to Approved), it should be implemented within your organization. Alert emails can be scheduled and sent to a human resource for the person responsible for implementing the recommendation.
7. To implement the recommendation, you can create a work request in a maintenance management system (e.g., an SAP Notification, an Oracle EBS eAM Work Request) by setting the value in the Create Work Request field in the RCA Recommendation to True.
8. After the recommendation is implemented, the value in the Status field in the RCA Recommendation should be changed to Implemented, and the RCA Recommendation is considered complete.
Note: This step is part of the Tracking and Reevaluating Analysis Results step in an RCA.
9. If the piece of equipment or location continues to fail, the RCA Recommendation should be flagged for reevaluation.
10. The team should meet to discuss the implemented recommendation, propose new recommendations, amend the original recommendations, and so on until an implemented solution prevents the piece of equipment or location from failing in the same manner that triggered the RCA.

About Tracking Items

A Tracking Item allows you to monitor the performance of an Asset and set up notifications to be sent when specific reevaluation criteria have been met (i.e. cost and the number of failures).

A Tracking Item queries the failure and cost data from work history records linked to the selected equipment or functional location. Queries are automatically initiated when the track item Start Date is reached. By default, the values in the Work History Total Cost field for Maintenance Work are used to derive the cost value used for the Count. The work history costs that occur prior to the track item Start Date will not be included in the Count. A track item alert is triggered when either the total cost or total number of failure events threshold count is met. After an alert is sent, the Count reverts to zero, and the process is repeated until the track items instruction is terminated.





Overview of the Root Cause Analysis (RCA) Module

The APM Root Cause Analysis (RCA) module lets you conduct a root cause analysis, which allows you to analyze causes of failures. A Root Cause Analysis also allows you to track the performance of the equipment by following implementation of recommendations. When you create a Root Cause Analysis, you are using APM tools to facilitate a standard process that is based on the [PROACT® for Meridium methodology](#).

Note: The RCA module is based on the PROACT® RCA Methodology, © Copyright 1996 - 2017, RCI-Reliability Center Incorporated. All rights reserved. Used with Permission.

More Details

A root cause analysis is the process of analyzing failures down to their root causes, which can include but is not limited to physical causes, human causes, and latent causes of the failure.

In the APM system, [elements of a Root Cause analysis](#) store all the information necessary for the team to identify a root cause for failure of an asset.

When the Root Cause Analysis is complete, it can be published and made available to users who are not members of the analysis team, allowing them to view the results using APM tools.

When a failure occurs in your facility, there could be any number of causes that led to the failure. If you investigate the causes, you might find that each failure is caused by another higher-level cause. If this root cause remains unidentified, the failures will likely persist.

For instance, consider an example of a car that has had trouble starting every month for the past three months. In this case, you might determine that:

- In the first month, the cold weather caused the failure.
- In the second month, the battery was low.
- In the third month, the warning to check engine was displayed in the dashboard.

If you were to conduct a root cause analysis on the car, you may find that while each month's failure had its own apparent cause, the root cause of each failure was that a voltage regulator was malfunctioning.

To help you identify the root causes of failures in your facility, you can assemble an RCA Team that will:

- Collect data relevant to the failure.
- Analyze the data.
- Develop hypotheses about the root cause.
- Develop recommendations for preventing the failure from occurring or lessen the impact of the failure in the future.
- Implement recommended solutions.
- Track implemented solutions and re-evaluate them, as needed.



About the Root Cause Analysis (RCA) Data Loader

The Root Cause Analysis (RCA) Data Loader allows both primary and third-party content to be delivered to APM through either the RCA Data Model. The imported data can then be used to maintain relationships between the RCA data and the Failure Modes and Hypotheses. Users can deploy the data loader to import:

- Legacy analysis data for performance comparisons.
- Third-party template content.

The Root Cause Analysis (RCA) Data Loader transfers data from a fixed-format Excel workbook into either the RCA Data Model or the RCA Logic Tree. The imported data can be:

- An RCA Analysis.
- An RCA Event.
- A Failure Mode.
- A Logic Gate.
- An RCA Hypothesis.
- An RCA Diagram Relationship.

Note: The Root Cause Analysis (RCA) Data Loader will not be backwards compatible to earlier versions of APM.

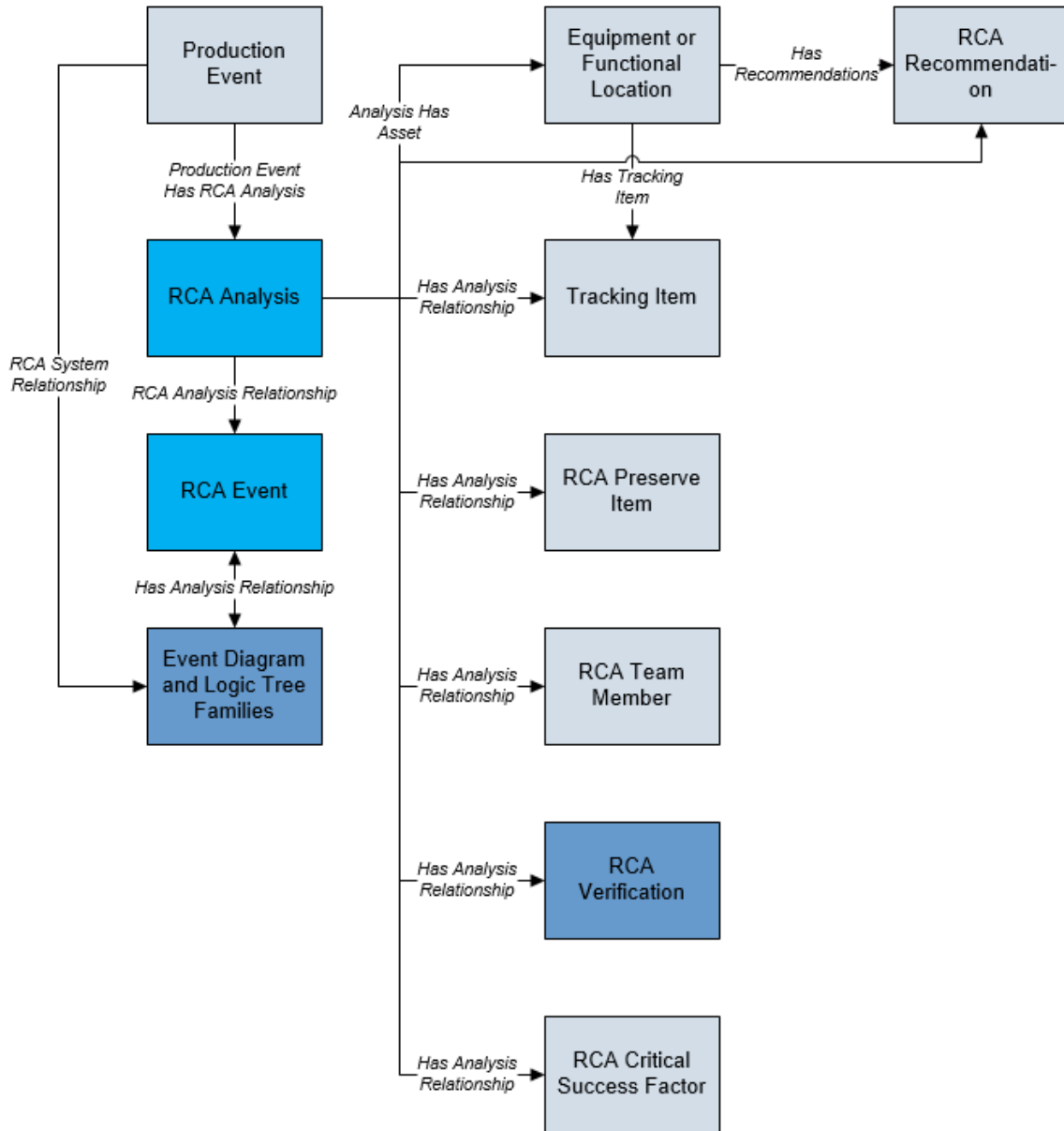

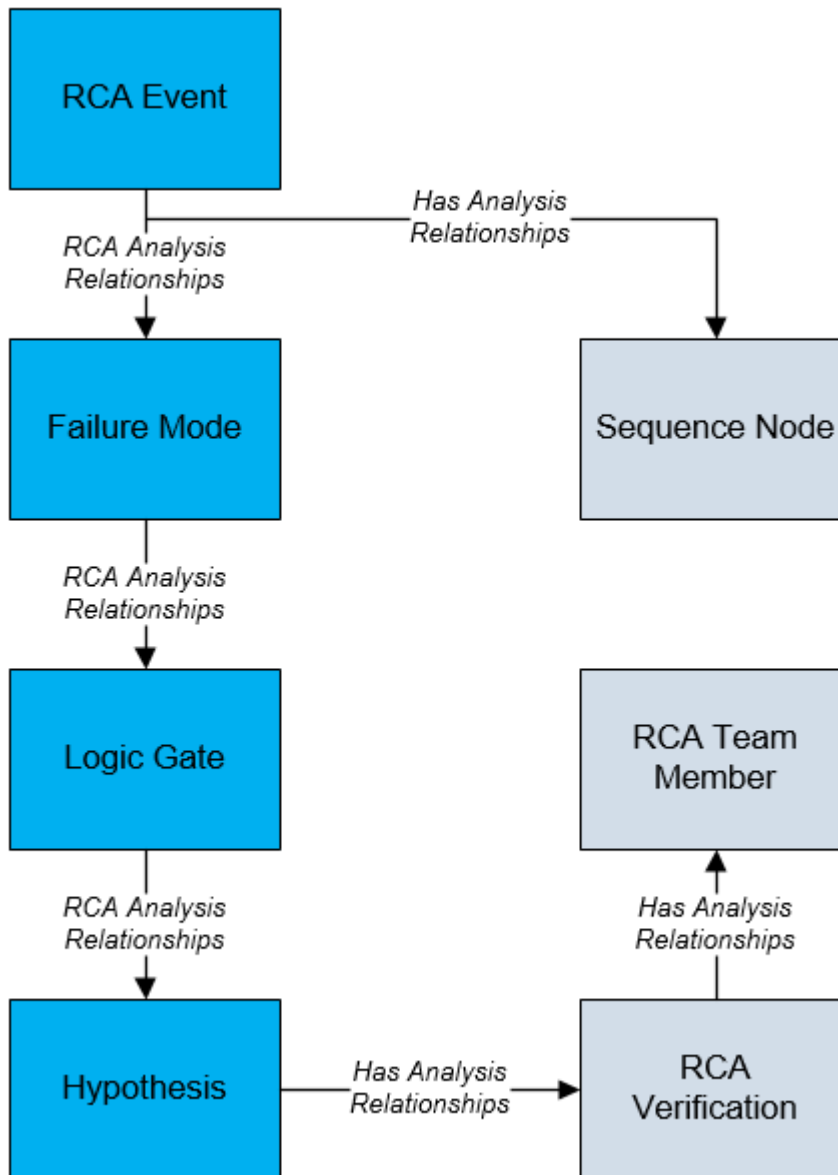

Best Practices

When importing data using the Root Cause Analysis (RCA) Data Loader, you must use the following best practices:

- ID fields (row 2 of each worksheet) must not include special characters or spaces.
- Columns in the worksheets should be formatted as either text or dates.

- The first two rows of each worksheet should not be edited.
- Only import a maximum of 500 analyses in each data load.

Limitations

This section documents a list of the limitations for the Root Cause Analysis (RCA) Data Loader:

1. The user must use the Root Cause Analysis (RCA) Data Loader workbook (Root Cause Analysis (RCA) .xlsx). Any modifications made by the user to the values in column headings in any of the worksheets will not be imported.

Note: Any column values in a customized format will not be imported by the Root Cause Analysis (RCA) Data Loader.

2. If the user imports the same data multiple times, the most recently imported data is included in the database. If a record currently resides in the database and is then reimported, the newly imported file will replace the existing file in the database. The Root Cause Analysis (RCA) Data Loader does not append the existing record.

Load Sequence

1. Create an RCA Analysis.
2. Create an RCA Event.
3. Link the RCA Event to the RCA Analysis through the RCA Analysis Relationship.
4. Create and link one or more Failure Modes to the RCA Event through the RCA Analysis Relationship.
5. Create and link one or more Logic Gates to a specific Failure Mode through the Has Analysis Relationship, where the Failure Mode is the predecessor of the Logic Gate.
6. Create and link one or more Hypotheses to a specific Logic Gate, through the Has Analysis Relationship, where the Hypothesis is the successor of the Logic Gate.

About the RCA Template Data Loader Workbook Layout and Use

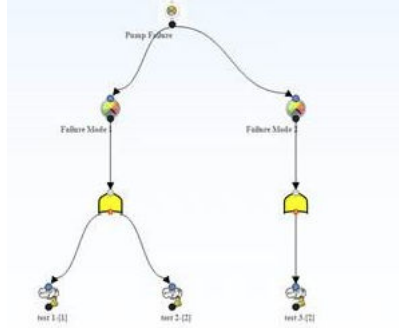
In order to import data using the Root Cause Analysis (RCA) Data Loader, we provide an Excel workbook (Root Cause Analysis (RCA).xlsx) that supports baseline Root Cause Analysis in APM. This template must be used to perform the data load. Using custom changes in code and in design, you can modify the Excel template to include custom fields used by your organization.

General Reference

An Example of a Root Cause Analysis

The sections in this topic correspond to each step in the [workflow for developing a Root Cause Analysis](#). In each section, the workflow for creating an RCA will be illustrated through examining the recurring failure(s) of a cooling water pump. The data used in each of the sections is listed in tables. In the tables, we list only the fields that contain a value. In the case of numeric fields, this includes fields that contain a value of zero (0). Fields that contain no value are not listed in the tables. The information in tables is provided for your reference.

Note: The information contained in these topics assumes that you are the user who will be performing the associated step in Root Cause Analysis and that all [RCA administrative tasks](#) have been completed.

Define criteria for when an RCA should be performed

Before you can begin conducting an RCA, you must establish the criteria that standardizes when an RCA should be performed. For example, the manager of the plant, where a cooling water pump exists, might specify criteria as:

- If any pump fails one or more times per week for more than two successive weeks, regardless of the cost for repairs, an RCA study should be conducted.
- or-
- If any pump fails catastrophically (e.g., causes the system to shut off), an RCA should be conducted.

Now, assume that in January 2015, the bearing temperature alarm, on the outboard bearing of a cooling water pump, sounded. By the time the operator arrived, the motor bearing temperature had increased to a point that the protective bearing temperature circuit caused the pump to shut down, resulting in loss of production. According to the criteria that was developed, these conditions dictate that an RCA should be performed. The first step is to create the analysis.


Create an RCA

If water pump failure meets the criteria for requiring an RCA, the first step is to create the analysis. The user who will serve as the Principal Analyst can complete this step and initiate the development of the RCA for the recurring failures of the cooling water pump.


1. [Access the RCA Overview page](#).
2. In the upper-right corner of the page, select **New Analysis**.
A blank datasheet appears in the **Analysis Summary** workspace.
3. Enter the values in the fields on the datasheet. For this example, you should create root cause analysis that contains the information as it appears in the following table:

Select the members of the RCA team

1. Access the **Team Members** section.

The list of human resources appears in the left section and the list of team members appears in the right section.
3. From the list of human resources, select the check box to the left of the following names to add as team members:
 - The analyst, Suzie Jones, to help gather information surrounding the failure.
 - The mechanic, Pete Handy, because he will repair the cooling water pump.
 - The engineer, Bob Speck, because he is an expert on systems and safety guidelines.
4. Select .
The selected names are added to the list of team members in the right section.
The Principal Analyst is Jane Doe, who is an expert on facilitating team discussion and documenting discussion notes.

Note: By default, the human resource that created an analysis will be added automatically as a team member and assigned the Principal Analyst role. You can change the Principal Analyst for an RCA.


Add Critical Success Factors

1. In the workspace, select the **Critical Success Factors** tab.
The **CSF** section appears.
2. In the upper-left corner of the workspace, select .

The **Available CSFs** and the **CSFs for this Analysis** subsections appear. The **Available CSFs** subsection contains the following **Critical Success Factors that an administrative user has pre-configured** for use with RCA:


- A cross-functional section of plant personnel/experts will participate in the analysis.
- A disciplined RCFA approach will be utilized.
- A measurement process will be used to track the progress of approved recommendations.
- All analysis hypothesis will be verified or disapproved.
- Management agrees to fairly evaluate the analysis team findings and recommendations.
- No one will be disciplined for honest mistakes.

Specify the Team Charter

1. In the workspace, select the **Definition** tab.
The **Definition** section appears.
2. In the **Charter** field, enter the following text:
To identify the root causes of the cooling water pump failure. This includes identifying deficiencies in or lack of management systems. Necessary recommendations for root causes will be communicated to the management for rapid resolutions.
3. Select .
The **Charter** field is updated.

Preserve Failure Event Data

You can preserve failure event data by creating an RCA Preserve Record, which contains a data-collection task that should be completed by the team member to whom the Preserve Record is assigned. Each task can be categorized according to the 5 P's (i.e., Parts, Paper, People, Position, Paradigms), which indicates the type of data that should be collected.

1. In the left pane, select the **Preserve Records** tab.
The **Preserve Records** workspace appears.
2. In the upper-left corner of the workspace, select .
The **New Preserve Record** window appears.
3. In the **Assigned to** list, select the team member to whom you want to assign the Preserve Records, and then enter values in the available fields on the Preserve Records datasheet.

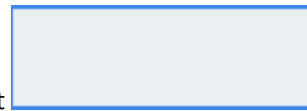



After the team has preserved the failure data, the team can begin to analyze the data. To help you visualize the event and organize the team's hypotheses and analysis, you should create an Event Diagram or a Logic Tree depending on your requirement. For our example, we will create a Logic Tree diagram.

1. In the left pane, select the **Logic Tree** tab.

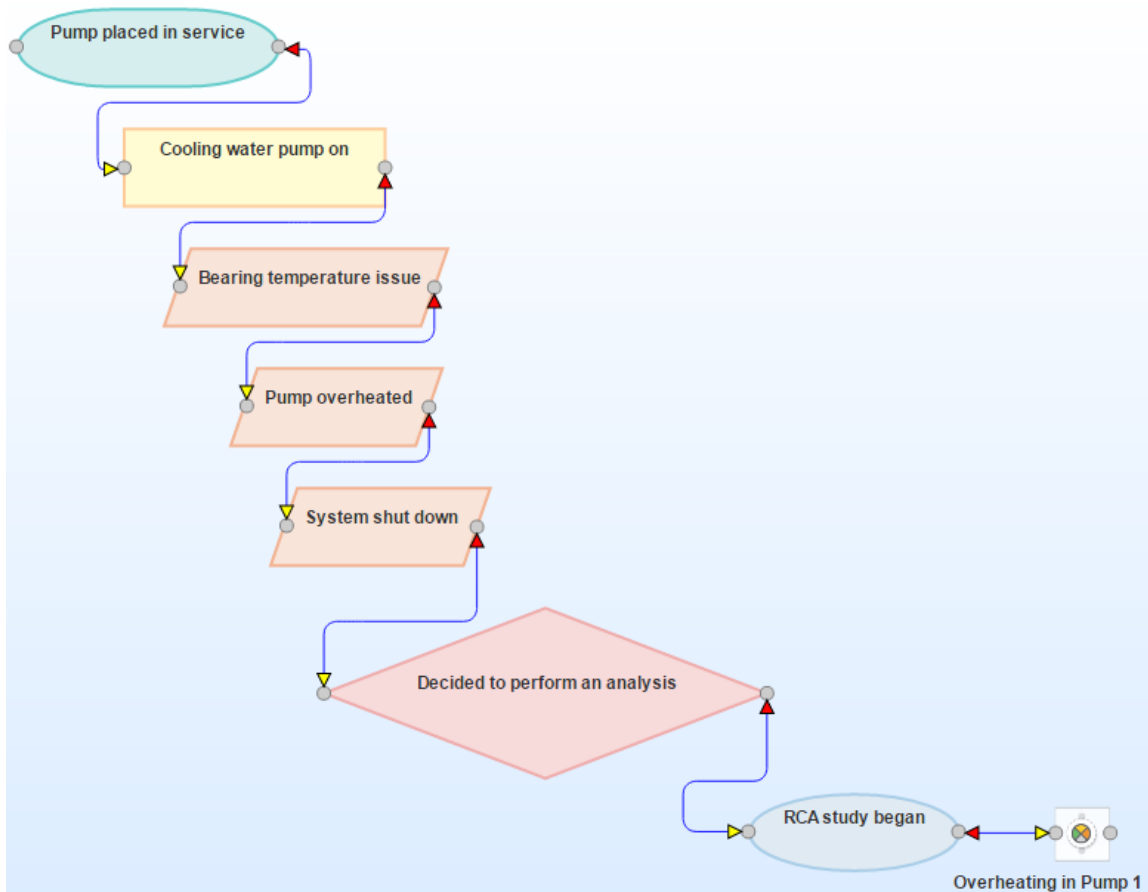

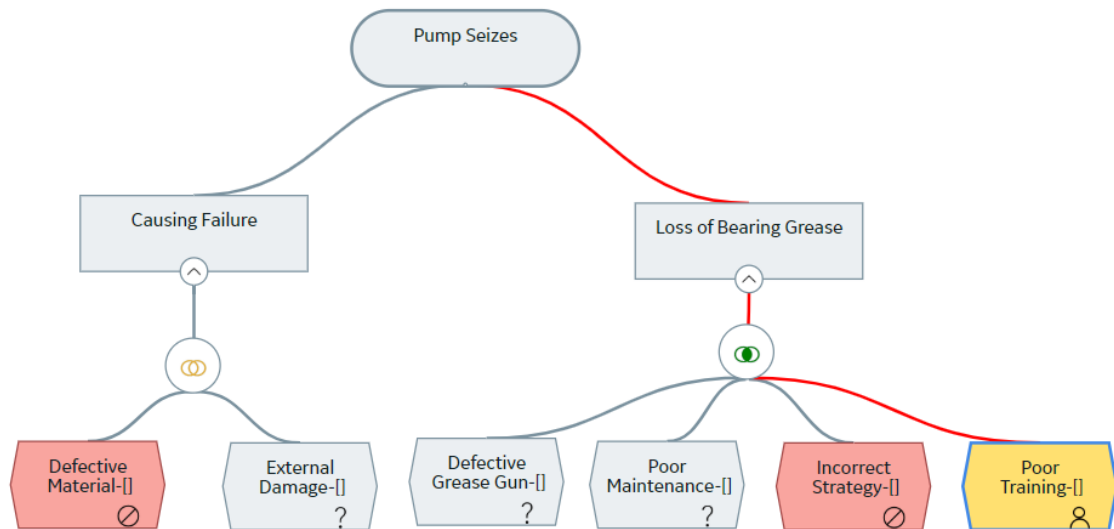

Diagram each failure mode in detail. For this example, you would create a Logic Tree like the one shown in the following image:



In the Logic Tree in this image, you can see that two Failure Mode nodes are linked to the Failure Event node, and multiple Hypothesis nodes are linked to the Motor Tripped due to high temperature Failure Mode node.

This example contains four RCA Logic Gates, which represent Logic Gate nodes and are used in the Logic Tree. You must [enable](#) Logic Gates to view them on the Logic Tree.



In the following table, the Logic Gates are numbered as they appear in the Logic Tree from left to right. For each RCA Logic Gate, the table displays the value in the [Gate Type](#) field of the RCA Logic Gate and identifying information about the node (e.g., RCA Failure Mode) to which it is linked.

Now that several likely hypotheses have been introduced, the team will need to rule out hypotheses. To rule out a hypothesis or prove a hypothesis, the hypothesis will need to be tested against the data that is available to the team (i.e., the failure event data and the team of experts).

As described in the next step, the Principal Analyst should create RCA Verifications and assign them to team members who will be responsible for completing the associated task.

12. [Select the Hypothesis](#) that you want to verify.
13. In the lower-left corner of the workspace, select the **Verifications** tab.
The **Verifications** pane appears.
14. Above the list, select .
The **Create Verification** pane appears.
15. In the **Assigned to** list, select the team member to whom you want to assign the Verification.

The task defined in this RCA Verification instructs the team member to inspect the wiring for the cooling water pump to ensure that the problem was not electrical, but mechanical.

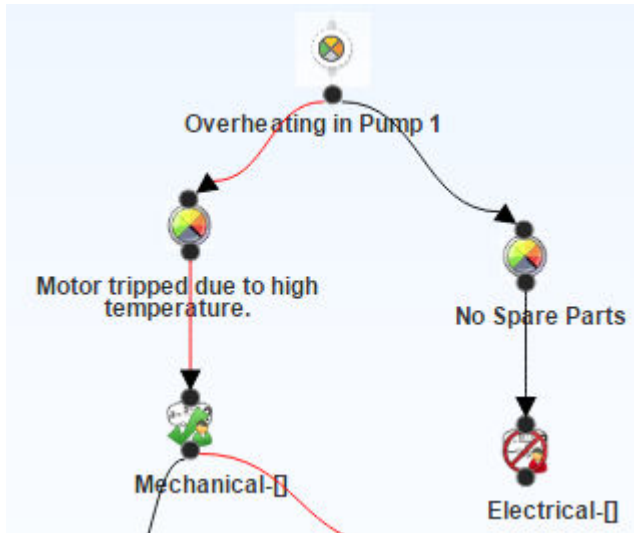
When a hypothesis has been tested, you must change the state of the associated RCA Hypothesis, as described in the next step.

17. [Select the Hypothesis](#) whose state you want to change.

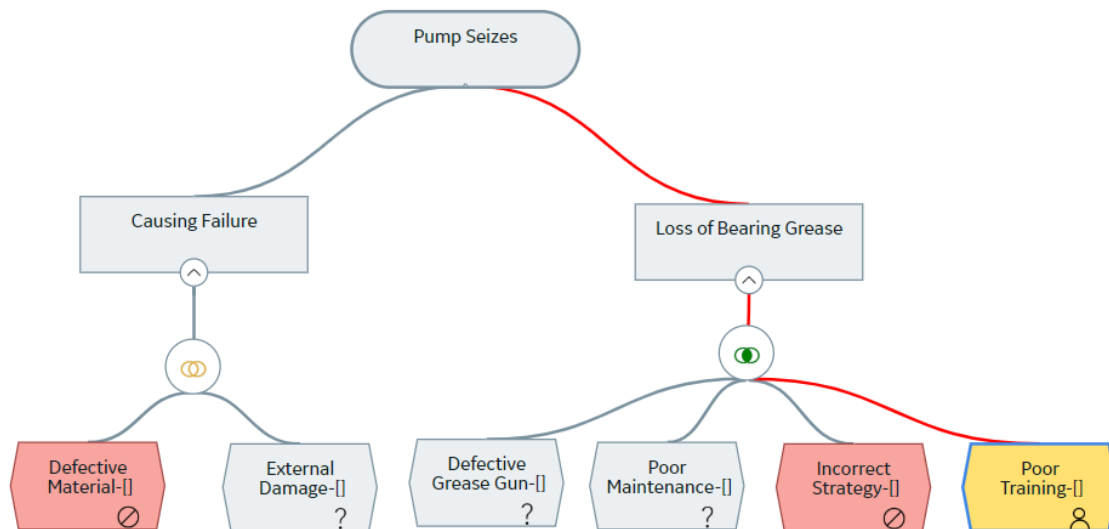
18. At the top of the workspace, in the **States** panel, select one of the following options, and then select :

- **Hypothesis True** if the hypothesis has been confirmed. After you determine a hypothesis to be true, you can [identify the root cause of the Failure Event](#).
- **Hypothesis Not True** if the hypothesis has been ruled out.

For example, the following image shows the Logic Tree after Pete Handy has completed the RCA Verification to which he was assigned. Pete Handy concluded that the wiring did not the cause the pump to overheat, so the problem must be mechanical.



After the state of the Mechanical RCA Hypothesis is set to True, the team can continue down the Logic Tree until they identify the root cause. Causes can be further identified as physical, human, or latent. For example, the following image shows the Logic Tree after ALL the RCA Verifications have been completed. The team has concluded that inadequate accountability of workers has led to insufficient lubricant being applied to the outboard bearing, which caused the motor's temperature to increase and the pump to overheat.





In this case, the root cause for the pump failure would be identified as latent (i.e., inadequate accountability of workers), which lead to human (i.e., too little applied) and physical (i.e., lubrication issue) causes. Now that a hypothesis has been verified and the root cause has been determined, you can create RCA Recommendations to communicate your findings on how to prevent this failure in the future.

If the hypothesis is not true but you cannot rule out the hypothesis and set the state to False, you can assign a probability to the hypothesis to include the team in determining the possibility of the hypothetical cause.


Communicating findings and recommendations

Now that the team has determined the root cause of the cooling water pump failure to be inadequate accountability of workers, you will want to record your findings and create RCA Recommendations. After recommendations have been implemented, you can share the results of the RCA with others. You can [access the RCA Overview page](#) to view the financial effects of implementing the recommendations. For our example, we will create one Recommendation record.

1. [Access the Root Cause Analysis](#) for which you want to create a recommendation.
2. In the upper-right corner the workspace, select the . The **Recommendations** pane appears.
3. Select . The RCA Recommendation datasheet appears.


- If you want to schedule a recommendation alert email to be sent to a specified recipient, select the **Alert** tab, and enter the necessary information on the datasheet.
- Select . The RCA Recommendation is saved to the database and linked to the analysis for the selected Root Cause analysis.

After you have successfully identified the root causes associated with the failure that was investigated, you can communicate the findings and propose recommendations to the appropriate individuals within your organization. You can communicate the findings [via a hyperlink to the analysis](#) or [via a summary report through email to selected recipients](#).

Tracking Results

After the RCA findings have been communicated and the recommendation has been implemented, the team will want to track the effectiveness of the recommendation to see if the new report has prevented the cooling water pump from failing thus far. Tracking for results involves creating RCA Tracking Items, scheduling the Tracking Evaluations in the APM Schedule Manager, and modifying the existing recommendation or creating a new one based on the discoveries that are made through reevaluation.

For our example, we will create one tracking item.

- [Access the RCA](#) within which you want to create a new Tracking Item.
- In the left pane, select the **Track** tab. The **Track** workspace appears.
- In the upper-left corner of the workspace, select . The **Add/Edit Tracking Item** window appears, displaying a blank datasheet.

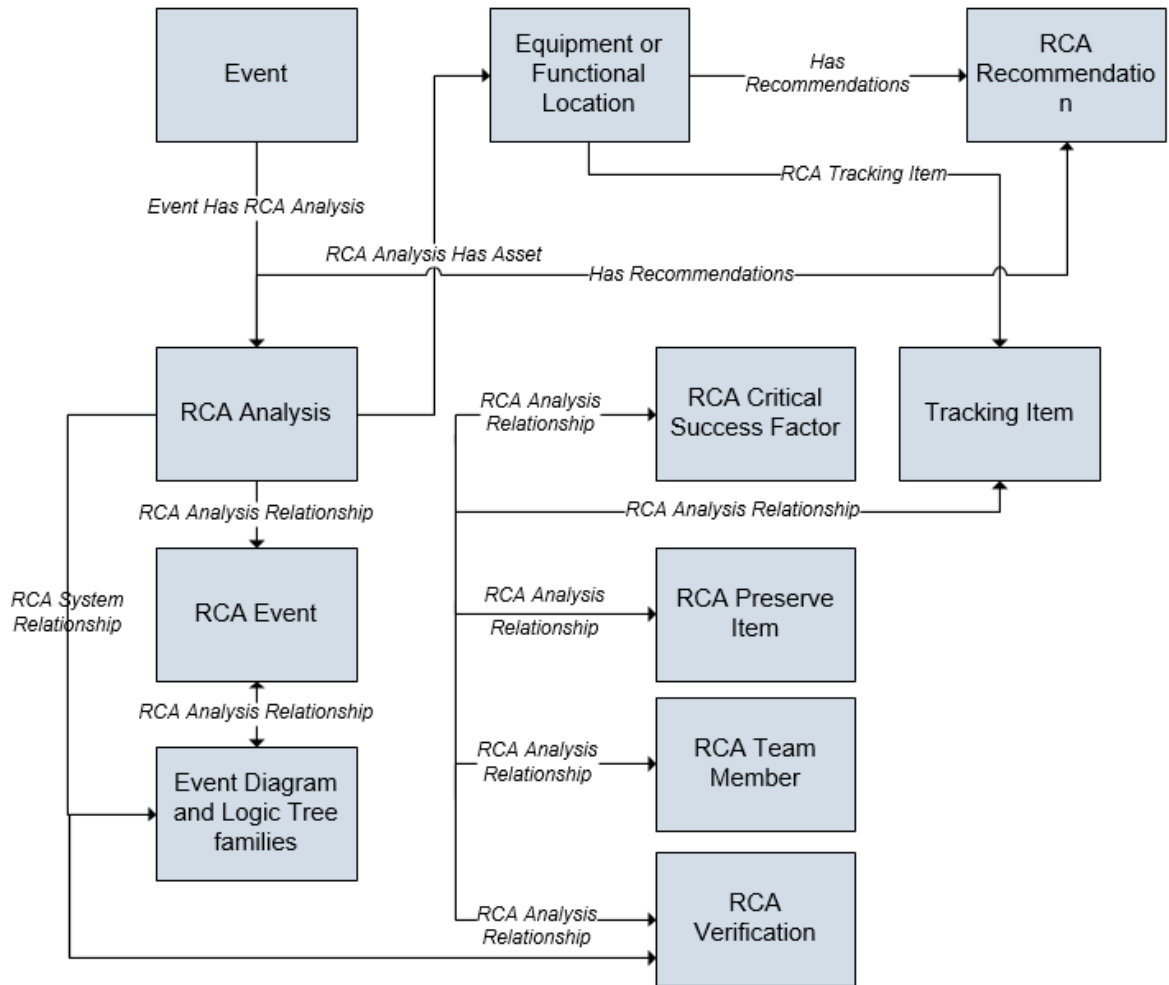

RCA Data Model

The Root Cause Analysis data model uses families to represent the various components of an RCA, as defined by the standard, accepted PROACT for RCA methodology. APM leverages its fundamental entity and relationship family infrastructure to store data related to an RCA.

Each RCA is represented at the root level by an RCA. The RCA can be linked to an RCA Event through the RCA Relationship. RCA Events can, in turn, be linked to RCA Failure Modes, RCA Sequence Nodes, and so on for all components of the RCA. Together, the RCA and all the records that are linked to it, either directly or indirectly, make up the Root Cause Analysis.

The following image shows the entity families and relationship families that are used to create an RCA.



Note: In the diagram, boxes represent entity families and arrows represent relationship families that are configured in the baseline database. You can determine the direction of the each relationship definition from the direction of the arrow head: the box from which the arrow originates is the predecessor, and the box to which the arrow head points is the successor.

Note: RCA Recommendations can be linked to [any Equipment and any Functional Location](#). They may or may not be the same Equipment or Functional Locations that are linked to the RCA.

The Root Cause Analysis Best Practice specifies that you will create RCA Analyses either for equipment or functional locations. Either option may be valid, depending on the analysis. Throughout the RCA documentation, we assume that you are following the APM best practice and storing your equipment and functional location information in Equipment and Functional Location records. Additionally, we assume that you are following the RCA Best Practice and linking your RCA records to either Equipment or Functional Location records.

In addition to the relationships that appear in this image, records in the following families can be linked to records in the RCA Reference Document family through a relationship definition on the Has Reference Documents family:

- RCA Analysis
- RCA Critical Success Factor
- RCA Event
- RCA Failure Mode

- RCA Preserve Item
- RCA Recommendation
- RCA Team Member
- RCA Tracking Item
- RCA Verification

Additionally, the following families are used by the RCA module but are not related to any other family in the data model:

RCA Site Filtering

An RCA is assigned a site on the **Definition** workspace and spread to all the related records, such as Logic Tree records and RCA Event records.

Tip: For more information, refer to the Site Filtering section of the documentation.

In RCA, users will see only Root Cause Analyses that are assigned to their site(s) or that are global records. In the Linked Assets section for a Root Cause Analysis, users will see all of the assets linked to the Root Cause Analysis, but will only be able to access those assets to which they have the necessary permissions.

Note: RCA Templates are designated as global records.

Example

Consider an organization that has three sites, Site X, Site Y, and Site Z. The following RCA Analysis records exist:

- RCA Analysis A: Assigned to Site X
- RCA Analysis B: Assigned to Site Y
- RCA Analysis C: Assigned to Site Z
- RCA Analysis D: No site assigned (global record)

Scenario 1: User assigned to only Site X

This user will see RCA Analysis A and RCA Analysis D.

Scenario 2: User assigned to both Site X and Site Y

This user will see RCA Analyses A, B and D.

Scenario 3: Super User

This will see RCA Analyses A, B, C and D.

Important: If a multi-site user, or a Super User, links child records from multiple sites to a parent record designated as Global, another user who does not have access to all sites may only see a portion of the data associated with that record. In the example above, if a child record assigned to Site X and a child record assigned to Site Y are linked to RCA Analysis D, the Site X user will not be able to see all the records associated with RCA Analysis D.

RCA Analysis records store basic information about a Root Cause Analysis created to track and analyze causes of Asset failures. Preserve Event Data

As in any investigative occupation, it is a REQUIREMENT that data (evidence) be collected from the scene and preserved in such a fashion as is appropriate for further analysis. As with the detective at a crime scene, the area is roped off and the scene preserved for the professionals who will come in and collect the necessary data.

PROACT® utilizes a data collection technique called the 5-P's. The 5-P's stand for the following five (5) data categories:

1. Parts – Physical or tangible evidence. Examples include process equipment, diagnostic equipment, fluid samples, etc..
2. Paper – Documentation. Examples include procedures, specifications, records, policies, test results, literature searches, etc.
3. Positional - Elements of time and space. Examples include times of occurrences, location of occurrences, frequency of occurrences, etc..
4. People - People sought to be interviewed regarding an event. Examples include management, administration, witnesses, engineers, hourly personnel, purchasing, etc.
5. Paradigms - People's belief systems that contribute to decision errors."Cost reduction is #1","It's the manufacturer's fault","Poor design", etc..

4. Establishing Critical Success Factors (CSF's) - Establishing CSF's that outline how the team will know when they have been successful.

Analyze the Event Data

Any undesirable outcome is a result of a series of "cause-and-effect" relationships. The data collected in the 5-P's section of this report will ultimately serve as proof (evidence) as to what actually did or did not occur.

A logic tree will be used in the PROACT® RCA approach to graphically express the "cause-and-effect" relationships discussed earlier. In this approach, the top two levels of blocks represent the Event (Level 1) and the Modes (Level 2). From level to level represents a "cause-and-effect" relationship. These levels specifically represent the "undesirable outcomes" that did occur (facts only)!

From the MODE level, we do not know why they have occurred, just that they did. From this point we become hypothetical and repeatedly ask the question "How Can?".

As hypotheses are developed in this fashion, we use our 5-P's data to verify what is true and what is not true. In this fashion, facts lead our analyses not assumptions. This process is reiterated until we start to uncover the real root causes; the reasons that people make decision errors that lead to undesirable outcome.

Root causes originate from flawed systems in which people depend on to make informed decisions. We call these Latent Root Causes or Organizational Root Causes. Flawed organizational systems lead to poor decisions being made by well-intentioned individuals. We call these the Human Root Causes. Decision errors lead to Physical Root Causes, or events or conditions that are visible.

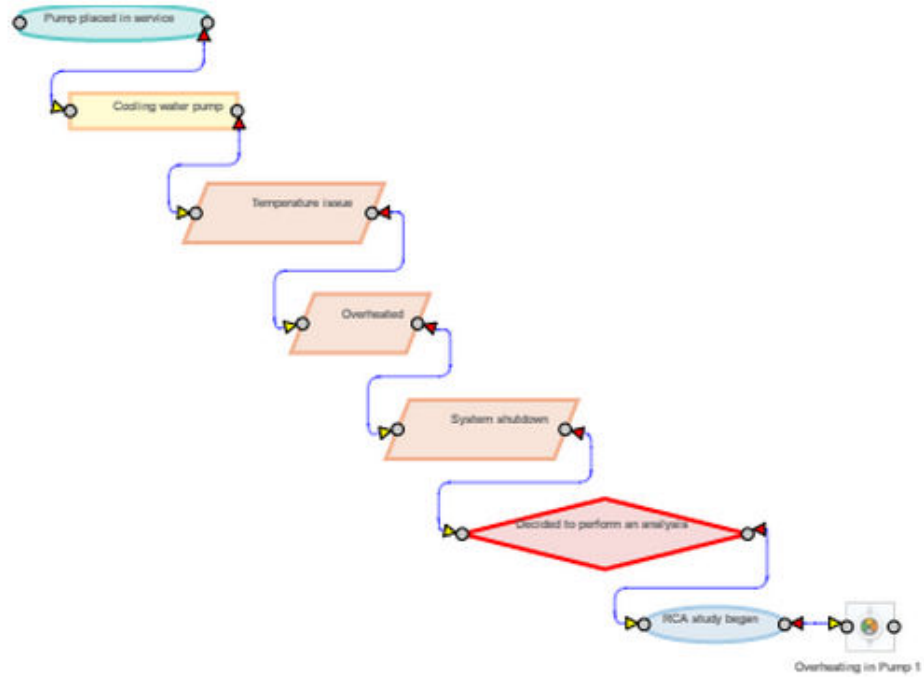
Only when we uncover the Latent Roots or Organizational System Roots are we actually conducting a "real" ROOT CAUSE analysis.

Tracking For Results

Once you have successfully communicated your finding and your recommendations have been implemented you must now track the effectiveness of those recommendations to ensure that you are getting the results that you have anticipated.

Tracking Evaluations help ensure that the approved PROACT® Recommendations are effective in addressing the underlying issues. During the evaluation process, the PROACT® Principal Analyst specifies a set of conditions (event-based) on which re-evaluation notifications for Tracking Items are based.

Event-based criteria represent a threshold for the number of failure events or the failure cost over a period of time following the implementation of the Recommendation. When the defined thresholds are exceeded, the Tracking Item is updated to a Re-evaluate status, and an e-mail reminder notifies the responsible party to re-examine the defined analysis information. For example, you may specify that a Tracking Item be evaluated if a failure that the analysis was intended to prevent actually occurs.

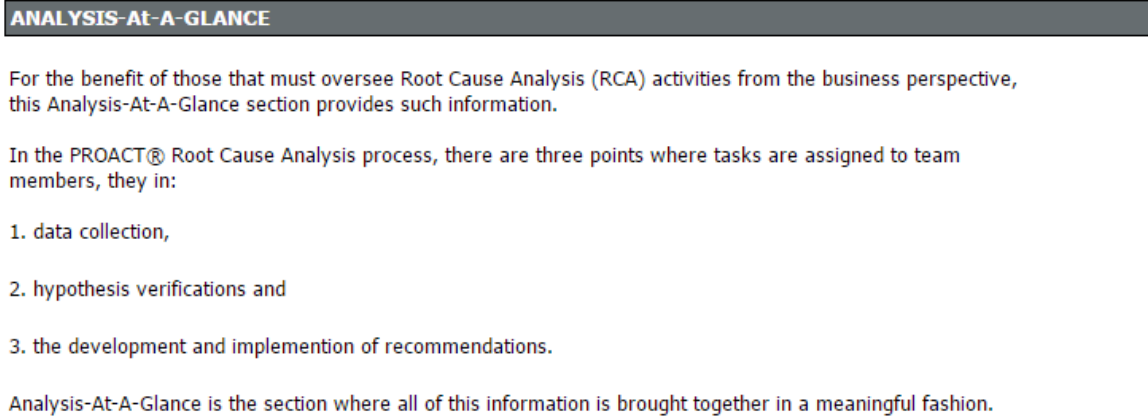

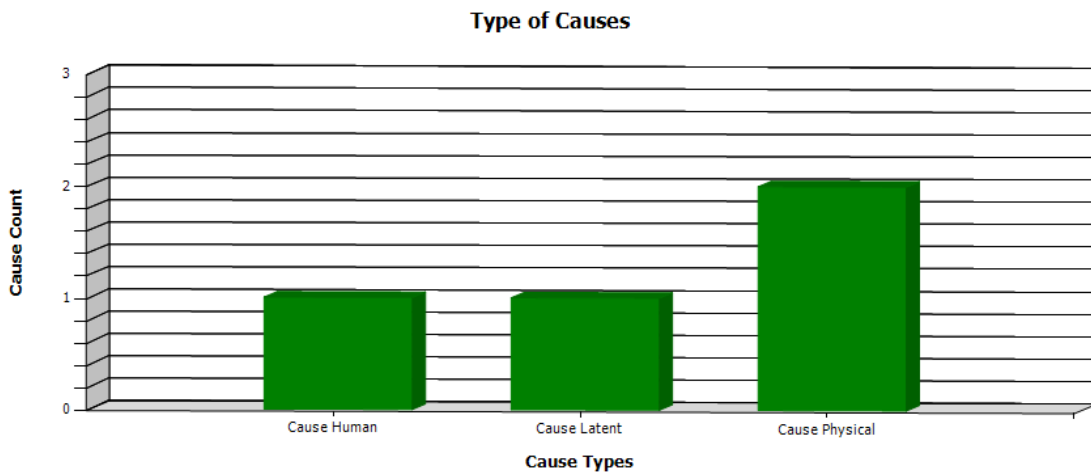

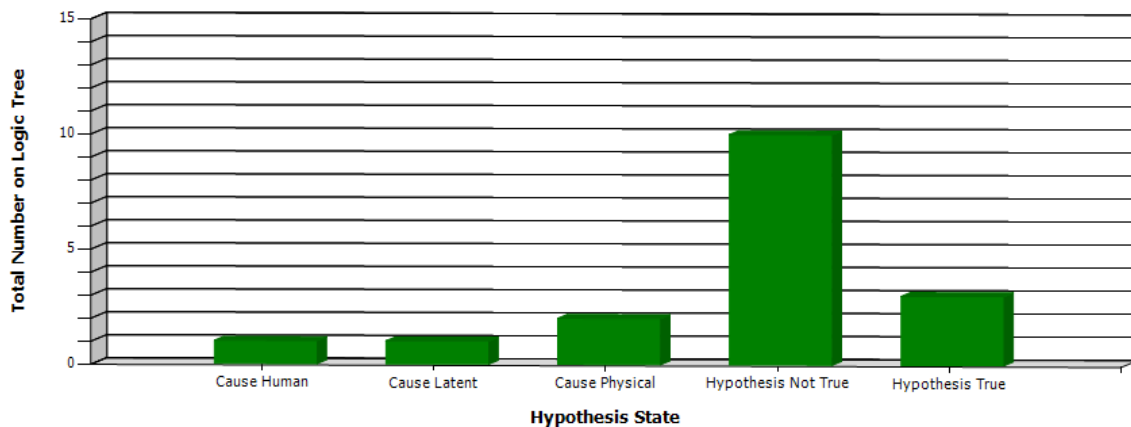
Logic Tree Summary Report
